SUBJECT:

Taser 7 Certification Program and Warranty Bundle for SAPD Amendment I

SUMMARY:

This ordinance will approve an amendment with AXON Enterprise, Inc. to add up to 400 Tasers for a total of 1,850 tasers and all related accessories, to the existing contract and increasing the contract by \$2,171,793.70 for a total contract amount of \$11,773,693.70. Funding in the amount \$63,962.85 for 65 Tasers to be purchased in FY 2025 is available from the FY 2025 General Fund Adopted Budget. Funding for subsequent years is contingent upon Council approval of the annual budget.

BACKGROUND INFORMATION:

On June 3, 2021, City Council approved a contract with Axon Enterprise, Inc. for a five-year contract, with a five-year renewal option for Taser 7 Certification Program and Warranty Bundles. The contract provided the most up-to-date taser model, and San Antonio Police Department (SAPD) purchased 1,450 tasers devices. This contract also provided instructor lead training, training cartridges delivered annually, and training suits.

This contract amendment will provide up to 400 additional taser devices, including all related accessories, to SAPD to be utilized as new officers are added. Also, the contract amendment will provide SAPD with related accessories to include all-inclusive Certification Program, Warranty Bundle, handles, holsters, unlimited field-use cartridges, recharging docks, rechargeable batteries, hardware warranty for 2 (five-year periods), and evidence.com licenses, for SAPD law enforcement officers. This amendment is effective throughout the original contract term and the one, five-year renewal option.
