City Council Chambers

The City Council convened a regular meeting in the Norma S. Rodriguez Council Chamber in the Municipal Plaza Building beginning at 9:15 a.m. City Clerk Debbie Racca-Sitre took the Roll Call noting a quorum with the following Council Members present:

PROCEDURAL

1. Invocation

The invocation was delivered by Reverend Ann E. Helmke, City of San Antonio Faith Liaison.

2. Pledge of Allegiance

Mayor Nirenberg led the assembly in the Pledge of Allegiance.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg let a moment of silence in honor of the Jonathan Joss who was murdered this week.

Mayor Nirenberg proclaimed the month of June 2025 to be Pride Month in honor of the Lesbian, Bisexual, Gay, Transgender, and Queer (LGBTQ+) Community and invited representatives to speak including: Chris Chun, Fiesta Youth + Board; Sofia Sepulveda, Equality Texas; Justin Holley, Thrive Youth Center; James Poindexter, Pride Bigger than Texas Parade; Erica Alcocer and Lex Loro, The Pride Center; and Avery Donovan, The San Antonio Gender Association.

Councilmember McKee-Rodriguez recognized representatives from American Indians in Texas at the Spanish Colonial Missions who honored fellow Native American Johnathan Joss who was an actor that helped bring more visibility to the Native American community.

ITEM FOR STAFF BRIEFING

3. Post-solicitation briefing on recommendations from three Requests for Proposals for Rental Housing Production, Rehabilitation, Preservation and Acquisition (Rental Housing), Homeownership Production, and Permanent Supportive Housing (PSH) estimating a total value of \$34 million from the 2022-2027 Affordable Housing Bond, HOME, HOME-ARP and CDBG programs. [Lori Houston, Assistant City Manager; Veronica Garcia, Director, Neighborhood and Housing Services Department]

Director of Neighborhood Housing Services Department (NHSD). Veronica Garcia. presented an overview of the procurement process and each project recommended for funding. City Manager Erik Walsh closed the staff presentation by mentioning the City Council's desire to go back to the voters with another Housing Bond prior to 2027 since the work done with the 2022 Bond Program was fully supporting the goals of the Strategic Housing Implementation Plan (SHIP) and there was more to be done. He noted that 2022 was the first Housing Bond Program implemented by the City of San Antonio and thanked NHSD staff and partners such as the San Antonio Housing Trust (SAHT) for their work.

DISCUSSION:

Mayor Nirenberg was pleased with the progress being made on the SHIP and the 2022 Bond Program which was supported by voters. He predicted continued success toward the goals of the SHIP noting that the Plan was a model for other cities throughout the country. Mayor Nirenberg stated that housing was a basic need for families to be successful and while affordable housing was foundational, market rate was also important to make the housing market healthy for everyone. He thanked NHSD for their work.

Councilmember Castillo was proud that more than 50% of the units were at 30% Area Median Income (AMI) which made them deeply affordable for families. She also supported partnerships with Opportunity Home and options for homeownership.

Councilmember Castillo highlighted the role of SAHT and was excited about the Robert E. Lee Hotel Project.

Councilmember Courage asked Chief Housing Officer, Mark Carmona, about the need for more affordable housing. Carmona reported that in 2021, the SHIP called for 28,000 total units and the City was well on its way to meet that goal, however, deeper affordability and permanent supportive housing were also needed. Councilmember Courage noted that the goal was set four years ago and so far, there were less than 10,000 in the pipeline, therefore, he recommended a separate Housing Bond before 2027.

Councilmember Courage expressed concern with combining a Housing Bond with an Infrastructure Bond related to a new downtown Arena as housing should be the focus. City Manager Walsh noted that when the SHIP was originally approved, it called for \$300 million of affordable housing investment and voters had recently amended the City Charter to allow for a housing bond. The 2022 Housing Bond was \$150 million so the original plan still needed more funding, according to City Manager Walsh.

Councilmember McKee-Rodriguez requested a semi-annual update on achievement of the SHIP goals and the policy recommendations within the Plan. Garcia indicated that NHSD had a dashboard and would make regular updates to the Planning & Community Development Committee (PCDC). As of now, about 10,000 of the 28,000 units had been completed or were within the pipeline, according to Garcia who noted that the City was about a third into the SHIP which was a 10-year plan, so housing was on track with about 33% of the units being achieved.

Councilmember McKee-Rodriguez recommended more focus on Permanent Supportive Housing (PSH). Garcia stated that PSH providers needed more incentives and support acquiring sites, getting zoning which was something SAHT could help provide.

Councilmember McKee-Rodriguez asked if Bexar County's investments were counted in the results. Garcia replied that the numbers included Bexar County's projects. City Manager Walsh noted that the last update to PCDC was two months ago, and information would be provided to the full City Council in a memorandum from that presentation and the one today.

Councilmember Alderete Gavito commented that the lack of affordable housing impacted homelessness which was a top concern of Council District 7 residents. She asked if Federal funding was at risk of being lost. Garcia stated that the funding in her presentation had already been allocated and was safe. Councilmember Alderete Gavito appreciated the visuals provided regarding what each level of AMI represented, and she supported preservation of housing as well as homeownership.

Councilmember Alderete Gavito asked about partnership with Toyota. Garcia indicated that Toyota had partnered on the Tezel Road Apartments to provide transportation and might consider expanding services to other projects.

Councilmember Mungia thanked members of the Housing Commission for their work and spoke in support of the new projects with the SAHT including the Robert E. Lee Hotel.

Councilmember Mungia highlighted the Habitat for Humanity property in Council District 4.

Councilmember Kaur thanked Mayor Nirenberg for his focus and leadership on Housing. She was excited about the Robert E. Lee Hotel noting that the loss of the Soap Factory Lofts had a significant impact on affordable housing so when the Hotel came up for sale it was important for SAHT to step in so that it could stay affordable. Therefore, she supported land banking as a strategy to meet the affordability goals of the SHIP.

Councilmember Kaur supported a review of the SHIP and providing an update to the full City Council at B Session since not all councilmembers were on PCDC. She supported a new housing bond.

Councilmember Viagran thanked NHSD for their efforts and hoped that the new City councilmembers were watching the session and would be ready to support meeting the goals of the SHIP.

Mayor Nirenberg noted that the Item was for briefing only so no action was taken.
