

## ORDINANCE

**APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED COST OF \$160,000.00 ANNUALLY, INCLUDED IN THE FY 2025 ADOPTED BUDGET: (A) EKF DIAGNOSTICS, INC., FOR CUVETTES AND SUPPLIES FOR LABORATORY AND DIAGNOSTICS EQUIPMENT FOR THE HEALTH DEPARTMENT; AND (B) RATIFYING A CONTRACT WITH SCHNEIDER ELECTRIC SYSTEMS USA, INC., FOR ANNUAL SUPPORT AND MAINTENANCE FOR CITY-OWNED LICENSES FOR SYSTEMS SUPPORTING THE RIVERWALK FLOOD CONTROL SYSTEM FOR A THREE YEAR PERIOD.**

**WHEREAS**, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

**WHEREAS**, this ordinance (A) approves a low bid contract with EKF Diagnostics, Inc., for cuvettes and supplies for laboratory and diagnostics equipment for the Health department for an estimated annual cost of \$69,000.00; and (B) ratifies a contract with Electric Systems USA, Inc., for annual support and maintenance for City-owned software licenses for the Foxboro DCS Systems that supports the City of San Antonio Riverwalk Flood Control System, known as Customer FIRST Support and Services Program - Premium Level beginning March 1, 2025, renewing annually and ending February 29, 2028, for a total cost of \$272,167.00; and

**WHEREAS**, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The low bid contract with EKF Diagnostics, Inc., for cuvettes and supplies for laboratory and diagnostics equipment for the Health department for an estimated annual cost of \$69,000.00 is hereby approved and the contract with Electric Systems USA, Inc., for annual support and maintenance for City-owned software licenses for the Foxboro DCS Systems that supports the City of San Antonio Riverwalk Flood Control System, known as Customer FIRST Support and Services Program - Premium Level, beginning March 1, 2025, renewing annually and ending February 29, 2028, for a total cost of \$272,167.00, is hereby ratified. Each is subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. A copy of the bid tabulation sheets and contracts are attached hereto and incorporated herein for all purposes as **Exhibit I**.

**SECTION 2.** Funds will be encumbered upon issuance of purchase orders, and payment is

authorized to the vendors identified herein for an estimated annual cost of \$160,000.00. All expenditures will be in accordance with the Fiscal Year 2025 budget, and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

**SECTION 3.** The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this ordinance.

**SECTION 4.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
