ORDINANCE

APPROVING A CONTRACT WITH SIDDON'S MARTIN EMERGENCY GROUP, LLC, FOR TWO REPLACEMENT WATER TANKER/PUMPER TRUCKS FOR THE SAN ANTONIO FIRE DEPARTMENT FOR A TOTAL COST OF \$1,149,304.00. FUNDING IS FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND FY 2025 ADOPTED BUDGET.

WHEREAS, an offer was submitted by Siddons Martin Emergency Group, LLC, through the Texas Local Government Purchasing Cooperative (a.k.a. the "Buyboard"), to provide the San Antonio Fire Department (SAFD) with two replacement water tanker/pumper trucks for a total cost of \$1,149,304.00 utilizing the BuyBoard Cooperative Contract No. 746-24; and

WHEREAS, these vehicles will be utilized by SAFD to transport water from streams, lakes, or hydrants to a fire scene; and

WHEREAS, this purchase meets the requirements under the terms of the Texas Local Government Purchasing Cooperative agreement adopted by the City of San Antonio by Ordinance No. 97097 on January 30, 2003; and

WHEREAS, funding is available from the Equipment Renewal and Replacement Fund FY 2025 Adopted Budget; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer submitted by Siddons Martin Emergency Group, LLC, to provide the San Antonio Fire Department with two replacement water tanker/pumper trucks for a total cost of \$1,149,304.00 utilizing the BuyBoard Cooperative Contract No. 746-24 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. A copy of the bid tabulation sheet and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount of \$1,149,304.00 is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5709080 as part of the Fiscal Year 2025 Adopted Budget approved by City Council.

SECTION 3. Payment in the amount up to \$1,149,304.00 is authorized to Siddons Martin Emergency Group, LLC, and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager, or the City Manager's designee, correct allocation to specific

SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
