Ada Saenz, CEO of Boys and Girls Club, supported the continued City funding of delegate agencies to provide vital services to San Antonio Youth.

Simon Salas, CEO for Good Samaritan, Inc., spoke in support of delegate agency funding and thanked the City Council for their continued support of their mission and of area residents needing their services.

Denise Barkhurst, representing delegate agency Big Brothers, Big Sisters, spoke in support of delegate agency funding for youth mentoring services.

Naomi and Rocky Ortiz spoke on behalf of the El Camino Family and the need for the City to advocate for small businesses along the Broadway Street business corridor and for City Council to consider bringing back the Fiesta parades to the corridor, which had positive economic impact to all businesses along it.

Paul Rodriguez with Up Partnerships spoke in support of Department of Human Services funding for delegate agency services.

Carl Merkle spoke to white collar crime, his unjust incarceration, and his seeking of reimbursement from the City for \$7,500 in legal fees he incurred.

Lillian Mirales and Andrea Ramirez spoke in support of youth program services and the need for funding of programs.
