ORDINANCE

AUTHORIZING THE EXECUTION OF AN ADVANCED FUNDING AGREEMENT BETWEEN THE CITY OF SAN ANTONIO AND THE TEXAS DEPARTMENT OF TRANSPORTATION (TXDOT). NO FUNDING WILL BE ACCEPTED FROM TXDOT FOR CONSTRUCTION-RELATED EXPENSES FOR THE ROOSEVELT AVENUE (VFW BOULEVARD TO HARDING BOULEVARD) PROJECT, LOCATED IN COUNCIL DISTRICT 3. FUNDS ARE AVAILABLE FROM 2022- 2027 GENERAL OBLIGATION BOND FUNDS INCLUDED IN FY 2025 – FY 2030 CAPITAL IMPROVEMENTS PROGRAM

WHEREAS, On May 7, 2022, San Antonio voters approved the 2022 Bond Program which authorized \$12,000,000.00 for the Roosevelt Avenue (VFW Boulevard to Harding Boulevard) project to provide bicycle and pedestrian enhancements by constructing sidewalks, a shared-use path on the west side of Roosevelt Avenue and traffic signal improvements; and

WHEREAS, the project will be managed and funded by the City construction is anticipated to begin in Summer 2026 and is estimated to be completed by Winter 2027; and

WHEREAS, Texas Department of Transportation (TxDOT) requires state municipalities to enter into a Advanced Funding Agreement (“AFA”) with TxDOT when construction and improvements exceeding \$1 million are made on roadways of the state highway system; and

WHEREAS, this ordinance authorizes the execution of an Advanced Funding Agreement between the City of San Antonio and the Texas Department of Transportation to allow the City to enter, construct and maintain city-funded infrastructure improvements totaling \$12 million as part of the Roosevelt Avenue (VFW Boulevard to Harding Boulevard) project, located within TxDOT right-of-way in Council District 3; there is no exchange of funds between TxDOT and the City upon execution of this agreement; and

WHEREAS, approval of this ordinance will continue the City’s commitment to maintaining and improving existing infrastructure in collaboration with other governmental agencies; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to execute an Advance Funding Agreement between the City of San Antonio and Texas Department of Transportation to allow the City to enter, construct and maintain

city-funded infrastructure improvements totaling \$12 million as part of the Roosevelt Avenue (VFW Boulevard to Harding Boulevard) project, located within TxDOT right-of-way.

SECTION 2. The City Manager or designee, or the Director of the Public Works Department or designee, is further authorized to execute any and all necessary documents to effectuate said agreement and acceptance.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
