Whereas, the City of San Antonio (City) entered into a contract with Astrophysics, Inc., for an extended warranty that includes maintenance and repair services for the XIS line of X-ray inspection systems in the SAT FIS building for the Aviation Department, which began on August 16, 2019 and, as renewed, terminates September 30, 2024 (the “Contract”); and

Whereas, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply, and

Whereas, this amendment is authorized with City Council approval pursuant to the section entitled “Amendments” in 006, General Terms & Conditions, of the above referenced contract, and the Contract is hereby amended as follows:

1. AMENDMENTS

- A. Section 005- Supplemental Terms & Conditions, Original Contract Term, is hereby revised to extend the Contract for an additional five-year period and reads as follows:

Contract Term:

This Contract began on August 16, 2019 and terminates on September 30, 2029.

- B. Section 005- Supplemental Terms & Conditions, Renewals, is deleted in its entirety.
- C. Attachment A – Price Schedule is revised to add:
 - i. US Silver Extended Maintenance Contract Term September 30, 2024- September 30, 2025, for \$8,760.00

- ii. US Silver Extended Maintenance Contract Term September 30, 2025- September 30, 2026, for \$10,072.00
- iii. US Silver Extended Maintenance Contract Term September 30, 2026- September 30, 2027, for \$11,250.00
- iv. US Silver Extended Maintenance Contract Term September 30, 2027- September 30, 2028, for \$12,600.00
- v. US Silver Extended Maintenance Contract Term September 30, 2028- September 30, 2029, for \$14,500.00

2. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.

3. ENTIRE AGREEMENT

This contract, as amended, embodies the complete agreement of the parties hereto with regard to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.
