ORDINANCE

APPROVING AN INTERGOVERNMENTAL SUPPORT AGREEMENT WITH THE UNITED STATES DEPARTMENT OF THE AIR FORCE 502D AIR BASE WING JOINT BASE SAN ANTONIO (JBSA) TO PROVIDE 911 EMERGENCY MEDICAL SERVICES TO JBSA-FT. SAM HOUSTON AND JBSA-CAMP BULLIS FOR A ONE YEAR IN THE AMOUNT OF \$1,532,651.00 REIMBURSEMENT TO THE CITY, WITH FOUR ONE-YEAR RENEWALS, APPROPRIATING FUNDS AND AUTHORIZING A PERSONNEL COMPLEMENT.

WHEREAS, in 2013, the United States Department of Defense received new authority to partner with state and local government entities to seek efficiencies and cost savings in the provision and acquisition of common services; and

WHEREAS, as part of a collaborative effort between the City and JBSA to explore opportunities across city services that could enable a more cost effective operation of the military installations, JBSA identified City EMS services as a potential cost saving mechanism; and

WHEREAS, the City Council has previously approved entering into agreements with JBSA for procurement of services in 2018 and 2020; and

WHEREAS, this Ordinance authorizes an Intergovernmental Support Agreement with JBSA, to accept and appropriate reimbursement funding for providing 911 EMS services, and authorizing a personnel complement; **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or the City Manager's Designee is authorized to execute an Intergovernmental Support Agreement with JBSA and authorized to establish an additional San Antonio Fire Department uniformed personnel complement. Said Intergovernmental Support Agreement appears in substantially final form in **Attachment I** attached hereto and incorporated herein for all purposes.

SECTION 2. (Financials to be provided)

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may,

subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
