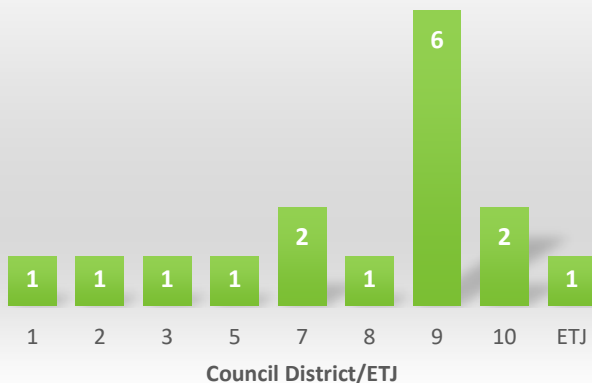

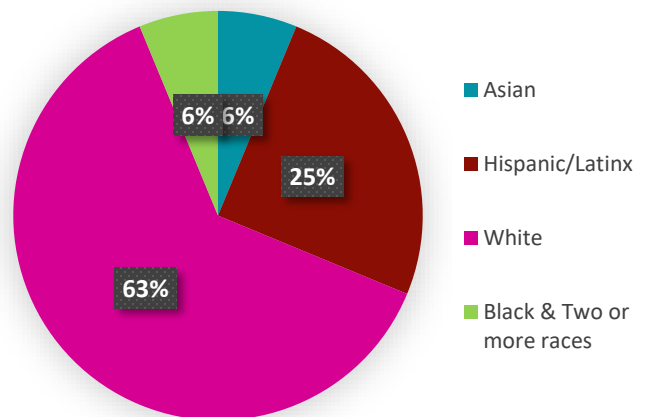

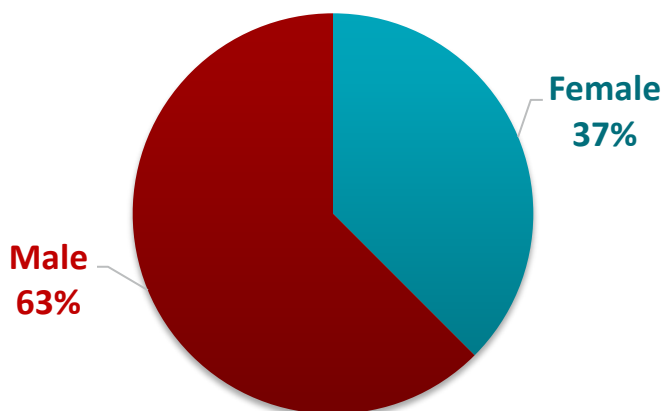
Council District Representation



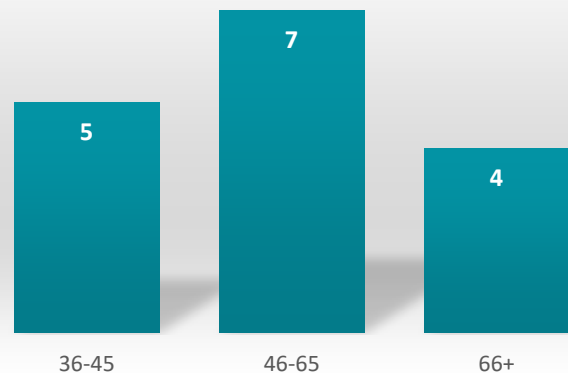
Applicant Ethnicity
