Whereas, pursuant to Ordinance No. 2021-05-13-0331 the City of San Antonio (City) entered into a contract with Vroozzi, Inc., for continued use of the Vroozzi Marketplace software platform which streamlines the catalog creation and management process for the Finance Department, Procurement Division, which began on April 1, 2021, and as renewed ends on March 31, 2025 (the “Contract”); and

Whereas, parties wish to amend the Contract to add an additional three-year renewal period and incorporate 36-month pricing for the renewal; and

Whereas, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply, and

Whereas, this amendment is authorized with City Council approval pursuant to the section entitled “Amendments” in 006, General Terms & Conditions, of the above referenced contract, and the Contract is hereby amended as follows:

1. AMENDMENTS

- A. Attachment A – Price Schedule is hereby revised to add the Vroozzi Catalog + Marketplace Platform Renewal Quote dated January 8, 2025, incorporated hereto as **Exhibit I**, for the 36-month term beginning April 1, 2025, and ending March 31, 2028, for the following Monthly Software Subscription Fees with Quarterly Billing for a total of **\$465,612**:

Year 1: \$12,763

Year 2: \$12,763

Year 3: \$13,275

B. Section 005 – Supplemental Terms & Conditions, Original Contract Term and Renewals, is revised to read:

Contract Term.

This Contract began on April 1, 2021, and shall terminate on March 31, 2028.

C. City shall not be required to sign **Exhibit I** as it has already been incorporated by reference as stated above. Any additional alterations, additions, or deletions to the terms hereof, must be effected by amendment, in writing, executed by both City and Vendor as required by the Amendments provision in the Contract.

2. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.

3. ENTIRE AGREEMENT

This contract, as amended, embodies the complete agreement of the parties hereto with regard to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.
