ORDINANCE

**APPROVING A TASK ORDER TO A JOB ORDER CONTRACT
WITH CON-COR, INC., IN THE AMOUNT NOT TO EXCEED
\$810,857.72 FOR THE BAZAN LIBRARY HEATING,
VENTILATION, AND AIR CONDITIONING (HVAC) PROJECT
LOCATED IN COUNCIL DISTRICT 5. FUNDS ARE AVAILABLE
FROM CERTIFICATES OF OBLIGATION INCLUDED IN THE FY
2025 - FY 2030 CAPITAL IMPROVEMENTS PROGRAM.**

WHEREAS, the Bazan Library is located at 2200 West Commerce Street and has been serving the residents of Council District 5. The existing Heating, Ventilation, and Air Conditioning (HVAC) system is over 15 years old and has exceeded its useful life. Its replacement is crucial to ensure the comfort and safety of the library users; and

WHEREAS, this task order utilizes the Job Order Contracting Program (JOC) approved through Ordinance 2022-02-17-0107 by City Council on February 17, 2022. Using the JOC delivery method provides the City with on-call construction, renovation and maintenance services for City buildings and facilities. Of the eight contractors approved as part of the JOC, Con-Cor, Inc. has been selected; and

WHEREAS, This proposed task order will provide for the work associated with removing and replacing the existing HVAC system equipment, including building automation controls, commissioning, testing, and balancing. Construction is anticipated to begin in Spring 2025 and is estimated to be completed by Summer 2025.; and

WHEREAS, Con-Cor, Inc. has committed to meeting the Small Business Economic Development Advocacy (SBEDA) Program and the Goal Setting Committee recommendation of a 24% Minority/Women Business Enterprise (M/WBE) subcontracting goal and a 3% African American Business Enterprise (AABE) subcontracting goal; and

WHEREAS, this Ordinance approves a task order to a Job Order Contract with Con-Cor, Inc., in the amount of \$810,857.72 for the Bazan Library HVAC project. Funds are available from Certificates of Obligation included in the FY 2025 – FY 2030 Capital Improvements Program;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to issue a Task Order to the Job Order Contract with Con-Cor, Inc. for the amount of \$810,857.72 for the for the Bazan Library HVAC project in Council District 5.

SECTION 2. Funds for this ordinance in the amount of \$810,857.72 is available in Fund 40099000, Project 23-04113, WBS Element 23-04113-05-02-01 and GL Account 5201140.

SECTION 3. Payment not to exceed \$810,857.72 is authorized to be encumbered with a purchase order and made payable to Con-Cor, Inc. Payment is in support for the Bazan Library Heating, Ventilation, and Air Conditioning (HVAC) project. Funding is provided by Certificate of Obligation bond funds and is included in the FY 2025 - FY 2030 CIP Budget.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
