**3. NCAA Final Four Traffic Plan**

Mr. Ragland stated that the NCAA has 25 spots in lot C for Dignitaries.

**5. Update on the Horse-Drawn Carriage CCR:**

Mr. Gilbert informed the TAB that City Council would hear the horse carriage CCR on December 5<sup>th</sup>.

**6. Discussion on Chapter 33 Taxicab Permits Availability:**

Mr. Gonzales stated that the taxicab industry is requesting that no new taxicab permits be issued.

Mr. Gonzales moved to amend Chapter 33 Sec. 33-929 (c) number of taxicabs permits ratio to one taxicab per 4,540 population within the legal boundaries of the city. Seconded by Mr. Strange.

**7. Discussion on Current Electric Vehicle Operations in San Antonio:**

Mr. Mery asked about the electric carriage in San Antonio. Mr. Gilbert stated that the electric carriage is registered with the State of Texas and can operate on the streets of San Antonio under the Neighbor Electric Vehicle (NEV) ordinance, but it cannot operate as a vehicle-for-hire and can not be permitted as an Electric Vehicle-for-Hire permit.

Mr. Mery questioned the number of Electric Vehicle-for-Hire permits available. Mr. Gilbert stated that we currently have 15 permits, and all permits have been issued.
