

FIELD NOTE DESCRIPTION

10-Foot Temporary Construction Easement 0.0634 of One Acre of Land (2762 sq. ft.)

Being a 0.0634 acre (2762 square feet) tract of land, situated in San Antonio, Bexar County, Texas; and being a portion of a called 4.785 acre tract known as Lot 34, New City Block 17726, Ely One Subdivision, Unit 2 as recorded in Volume 9576, Page 61, Deed and Plat Records Bexar County Texas, as conveyed to Classen Road Property, LTD in Volume 12123, Page 395 of the Official Public Records of Bexar County, Texas; said 0.0634 acres being more particularly described by metes and bounds as follows with all bearings being referenced to the North American Datum 1983, Texas Coordinate System, South Central Zone:

Beginning, at a set 1/2-inch iron rod with Stantec Cap on the North right-of-way line of Classen Road (variable width R.O.W.) on the Southerly line of said Lot 34 and the Southwesterly line of a remaining portion of a called 244.5 acre tract as recorded in Volume 18375, Page 309, Official Public Records of Bexar County, Texas;

Thence, along the arc of a curve to the left, having a chord of N 78° 22' 45" W, 8.32 feet, a radius of 1141.25 feet and a central angle of 00° 25' 03", a distance of 8.32 feet, to a set 1/2-inch iron rod with Stantec Cap for corner at a point of tangency;

Thence, N 78° 35' 16" W, 105.72 feet, to a set 1/2-inch iron rod with Stantec Cap for corner at a point of curvature;

Thence, along the arc of a curve to the right, having a chord of N 73° 32' 52" W, 161.67 feet, a radius of 903.77 feet and a central angle of 10° 15' 46", a distance of 161.88 feet, to a set 1/2-inch iron rod with Stantec Cap for corner; said point being on the Northerly line of said Lot 34 and the Southerly line of Lot 1, New City Block 17726, Classen Road Subdivision as recorded in Volume 9590, Page 151 of the Deed and Plat Records of Bexar County, Texas;

Thence, N 45° 33' 39" E, 10.96 feet, along the common line of Lot 34 and Lot 31, to a point for the Northeasterly corner of the herein described tract;

Thence, along the arc of a curve to the left, having a chord of S 73° 41' 26" E, 155.45 feet, a radius of 893.77 feet and a central angle of 09° 58' 41", a distance of 155.65 feet, to a point of curvature for corner;

Thence, S 78° 35' 16" E, 105.73 feet, to a point of curvature for corner;

Thence, along the arc of a curve to the right, having a chord of S 78° 12' 51" E, 15.02 feet, a radius of 1151.25 feet and a central angle of 00° 44' 50", a distance of 15.02 feet,

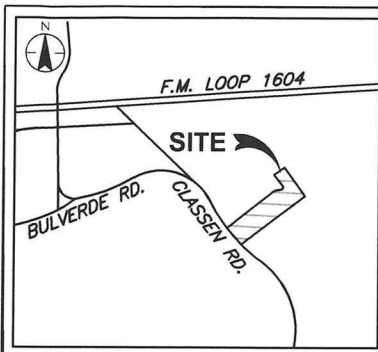

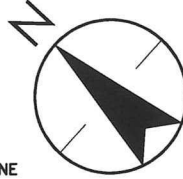
