### FIELD NOTE DESCRIPTION

Variable Width Right-of-Way Acquisition (fee simple)  
0.0201 of One Acre of Land (877 sq. ft.)

Being a 0.0201 acre (877 square feet) tract of land, situated in San Antonio, Bexar County, Texas; and being a portion of a 4.875 acre tract known as Lot 34, New City Block 17726, Ely One Subdivision, Unit 2 as recorded in Volume 9576, Page 61, Deed and Plat Records Bexar County Texas, as conveyed to Classen Road Property, LTD in Volume 12123, Page 395 of the Official Public Records of Bexar County, Texas; said 0.0201 acres being more particularly described by metes and bounds as follows with all bearings being referenced to the North American Datum 1983, Texas Coordinate System, South Central Zone:

**Beginning**, at a set 1/2-inch iron rod with Stantec Cap for corner on the Southerly line of said Lot 34 and the Southwesterly line of a remaining portion of a called 244.5 acre tract as recorded in Voume 18375, Page 309, Official Public Records of Bexar County, Texas, from which a point on the Northerly right-of-way line of Classen Road Bears S 45° 24' 32" W, 3.63 feet;

**Thence**, S 45° 24' 32" W, 3.63 feet, to a point for corner on the Northerly right-of-way line of said Classen Road;

**Thence**, N 79° 02' 59" W, 96.42 feet, to a point of curvature;

**Thence**, along the arc of a curve to the right, having a chord of N 73° 25' 49" W, 178.69 feet, a radius of 912.37 feet and a central angle of 11° 14' 21", a distance of 178.97 feet, to a point for the Northwesterly corner; said point being on the Northerly line of said Lot 34 and the Southerly line of Lot 1, New City Block 17726, Classen Road Subdivision as recorded in Volume 9590, Page 151 of the Deed and Plat Records of Bexar County, Texas;

**Thence**, N 45° 33' 39" E, 2.37 feet, along the common line of Lot 34 and Lot 1, to a point for the Northeasterly corner of the herein described tract;

**Thence**, along the arc of a curve to the left, having a chord of S 73° 32' 52" E, 161.67 feet, a radius of 903.77 feet and a central angle of 10° 15' 46", a distance of 161.88 feet, to a set 1/2-inch iron rod with Stantec Cap for corner at a point of tangency;

**Thence**, S 78° 35' 16" E, 105.72 feet, to a set 1/2-inch iron rod with Stantec Cap for corner at a point of curvature;

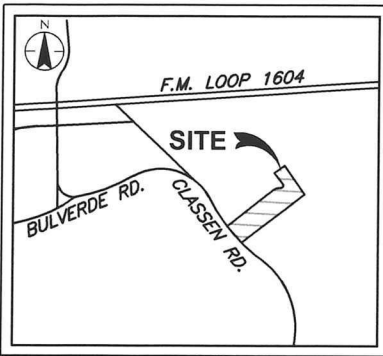

N.T.S.

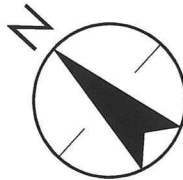
