Item #2 – Emergency Demolition # INV-DPE-INV24-2910000463 **1722 N. Center**
Owner: Fernandez, Eugenia & Steven & Fernandez, Sr. Emilio & Idolina

1722 N. Center, Emergency Demolition was read into the record. Jenny Ramirez, Code Enforcement Manager, presented to the board.

Item #3 – Dilapidated Structure Case # INV-BSB-INV22-2900000582 **435 S. San Manuel St.**
Owners: Garcia, Elias Jr. & Amelia H.

435 S. San Manuel St. is a residential single-family structure. Bexar County Appraisal District shows that Garcia, Elias Jr. & Amelia H. are the title owners. The owners were present to provide testimony. Stephanie Sanchez, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that the property is a public nuisance per City Code Chapter 6, Article VIII, Section 6-157, meeting the nuisance definitions of a dangerous building found in City Code Chapter 6, Article VIII, Section 6-156, for the main structure, sub-sections 1, 2, 4, 5, 7, 8, 11, 12,

15, 17, and 18. All notices were issued as required with the first notice issued on August 10, 2022. Staff recommends demolition.

The Board found the property to be a public nuisance. A motion was made by Kayla Miranda to demolish the main structure within 30 days. It is also ordered that the property be secured. Joel Solis seconds the motion.

***Item #4 – Dilapidated Structure Case # INV-BSB-INV22-2900000480 109 San Juan Rd.
Owner: Villarreal, Raul***

109 San Juan Rd. is a residential single-family structure. Bexar County Appraisal District shows that Villarreal, Raul is the title owner. The owner was not present to provide testimony. SAPD officer: Jimmy Martinez; Owner's son: Richard Villarreal; and Richard Villarreal's son in law: Louis Vega, were present and provided testimony. Sergio Quintanilla, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that property is a public nuisance per City Code Chapter 6, Article VIII, Section 6-157, meeting the nuisance definitions of a dangerous building found in City Code Chapter 6, Article VIII, Section 6-156, for the main structure, sub-sections 1, 2, 8, 11, 12, and 15. All notices were issued as required with the first notice issued on July 15, 2022. Staff recommends demolition.

A motion was made by Kayla Miranda to reset the case in 60 days. Joel Solis seconds the motion. 5-0-0 vote.

Owner: Rodriguez, Maria C. Est of***

3108 W. Martin St. is a residential single-family structure. Bexar County Appraisal District shows that Rodriguez, Maria C. Est of, is the title owner. The owner was not present to provide testimony. Bregarian Bledsoe, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that the property is a public nuisance per City Code Chapter 6, Article VIII, Section 6-157, meeting the nuisance definitions of a dangerous building found in City Code Chapter 6, Article VIII, Section 6-156, for the main structure, sub-sections 1, 2, 4, 5, 7, 8, 11, 12, 15, 17, and 18, and for the accessory structure, sub-sections; 8, 11, 12, 15, 17, and 18. All notices were issued as required with the first notice issued on November 20, 2023. Staff recommends demolition.

The Board found the property to be a public nuisance. A motion was made by Joel Solis to demolish the main and accessory structure within 30 days. It is also ordered that the property be secured. Robert Tapia seconds the motion.

Item #6 – Dilapidated Structure Case # INV-BSB-INV24-2900000072

201 Mohawk St.

Owners: Ramos, Lorraine & Barajaz, Jose

201 Mohawk St. is a residential single-family structure. Bexar County Appraisal District shows that Ramos, Lorraine & Barajaz, Jose are the title owners. The owners, Lorraine Ramos and Jose Barajas provided testimony via Worldwide Languages representative, Justa Garcia-Higby; SAPD officer: Brandon Guillen; and owner's son: Bobby Ramos were present and provided testimony. Kristy Garza, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that the property is a public nuisance per City Code Chapter 6, Article VIII, Section 6-157, meeting the nuisance definitions of a dangerous building found in City Code Chapter 6, Article VIII, Section 6-156, for the main structure, sub-sections 1, 2, 5, 7, 8, 11, 12, and 15, and for the accessory structure #1, sub-sections; 1, 2, 5, 7, 8, 11, 12, 15, 17, and 18 and for accessory structure #2, sub-sections; 1, 2, 5, 7, 8, 11, 12, 15, 17, and 18. All notices were issued as required with the first notice issued on February 1, 2024. Staff recommends repair for the main structure and demolition for the accessory structures.

The Board found the property to be a public nuisance. A motion was made by Kayla Miranda to repair the main structure within 90 days and a 30-day demolition for the accessory structures. It is also ordered that the property be free of trash and debris and progress reports provided to code every 30 days for the main structure repair. Joel Solis seconds the motion.

721 E. Huisache Ave. is a residential single-family structure. Bexar County Appraisal District shows that Dorinda Wilson & Ofilia Paredes & Jane Tunzi and Edward De Hoyos, Elizabeth Moore & Elaine De Hoyos Cano are the title owners. The owner, Elaine Cano was present; signed up to speak, but did not provide testimony. Attorney Edward Cano, and SAPD officer Juan Hernandez, were also present and provided testimony. Khrystal Towne, Dangerous Premises Officer, with the City of San Antonio Code Enforcement Section found that property is a public nuisance per City Code Chapter 6, Article VIII, Section 6-157, meeting the nuisance definitions of a dangerous building found in City Code Chapter 6, Article VIII, Section 6-156, for the main structure, sub-sections 1, 2, 8, 11, 12, and 15. All notices were issued as required with the first notice issued on December 21, 2023. Staff recommends demolition.

The Board found the property to be a public nuisance. A motion was made by Robert Tapia to demolish the main structure within 30 days. It is also ordered that the property be vacated, secured, utilities disconnected and free of trash and debris. Joel Solis seconds the motion.

Judy Croom, BSB Liaison, stated Panel B will meet on July 11, 2024, and Panel A will meet on July 18, 2024.
