

**AMENDMENT AND EXTENSION II  
TO  
BLOOD SERVICES AGREEMENT**

This Amendment and Extension II is entered into by and between the **City of San Antonio**, a Texas Home-Rule Municipal Corporation, (hereinafter referred to as “City”) acting by and through its City Manager or designee, pursuant to Ordinance No. \_\_\_\_\_ passed and approved on the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_ and the **South Texas Blood & Tissue Center**, a Texas not-for-profit organization (“STBTC”). City and STBTC are sometimes hereafter collectively referred to as the “Parties”.

**WHEREAS**, the City entered into a Blood Services Agreement (“Agreement”) effective September 1, 2018, with STBTC for scheduled delivery service of blood, blood components, supplies and other materials furnished by STBTC, reference and consultation services, periodic blood banking educational programs and in services for San Antonio Fire Department (“SAFD”) personnel; and

**WHEREAS**, the Agreement was amended and extended through September 30, 2024, by Ordinance No. 2019-06-20-0552; and

**WHEREAS**, the Parties mutually agree to and desire to extend the term of the Agreement for an additional one-year period, beginning October 1, 2024 and ending September 30, 2025; **NOW, THEREFORE:**

The Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described. City and STBTC agree to amend the Agreement as follows:

**ARTICLE I  
PURPOSE AND EFFECTIVE DATE**

The purpose of this Amendment and Extension II is to amend the said Blood Services Agreement to extend the term and to replace and supersede the Confidential Fee Schedule with the attached Exhibit A, Fee Schedule, Effective September 1, 2024. This amendment shall be effective upon approval by the San Antonio City Council and execution by Parties.

**ARTICLE II  
AMENDMENTS**

**2.01** Section 5, “Term”, is amended to extend the term, with the extended term ending September 30, 2025, as set out below:

**5. Term.** This Agreement shall commence on the Effective Date ascribed above, and will terminate on September 30, 2025, unless terminated for cause as provided herein.

If funding for the entire Agreement is not appropriated at the time this Agreement is entered into, City retains the right to terminate this Agreement at the expiration of each of City's budget periods, and any additional contract period beyond the initial term set forth in this section is subject to and contingent upon subsequent appropriation.

**ARTICLE III**  
**TERMS AND CONDITIONS**


All other terms, conditions, covenants and provisions of the Agreement are hereby continued and shall remain in effect in their original form, except for the provisions modified by this Amendment and Extension II.

**EXECUTED** and **AGREED** to as of the dates indicated below. This Amendment and Extension II may be executed in any number of counterparts, each of which shall be deemed an original and constitute one and the same instrument.
