

ORDINANCE

APPROVING THE FIRST AMENDMENT TO THE DEVELOPMENT AGREEMENT BETWEEN THE WESTSIDE TAX INCREMENT REINVESTMENT ZONE BOARD OF DIRECTORS AND ESPERANZA PEACE AND JUSTICE CENTER FOR THE RINCONCITO DE ESPERANZA PROJECT LOCATED IN COUNCIL DISTRICT 5 FOR A NEW PROJECT COMPLETION DATE.

WHEREAS, in accordance with the Tax Increment Financing Act (the “Act”), Chapter 311 of the Texas Tax Code, the City through Council Ordinance No. 2008-12-11-1173, established Tax Increment Reinvestment Zone Number Thirty, known as the Westside TIRZ, and a Board of Directors (“Board”) authorized with all the rights, powers, and duties provided by the Act, in order to promote development and revitalization activities within TIRZ; and

WHEREAS, the City and Board recognize the importance of their continued role in economic development, community development and urban design; and

WHEREAS, the Project consists of the rehabilitation of real property located at 816 S Colorado Street, San Antonio, TX 78207 San Antonio, Texas, in City Council District 5, and within the boundary of the Westside TIRZ; and

WHEREAS, on February 4, 2021, through Ordinance 2021-02-04-0067, City Council authorized the execution of the Rinconcito de Esperanza Project Funding Agreement with Esperanza Peace & Justice Center for an amount not to exceed \$1,500,000; and

WHEREAS, in accordance with Section 311.010(b) of the Act, the Board is authorized to enter into agreements to dedicate revenue from the tax increment fund to pay for eligible project costs related to the construction of public infrastructure and eligible project costs that benefit the TIRZ; and

WHEREAS, on September 29, 2023, the Westside TIRZ Board approved Resolution T30 2023-09-29-02R authorizing the First Amendment to the Rinconcito de Esperanza Project Funding Agreement for the Rinconcito de Esperanza Project to amend the project completion date to December 31, 2024 for the Rinconcito de Esperanza Project; and

WHEREAS, it is now necessary for the City Council to approve the First Amendment to the Rinconcito de Esperanza Project Funding Agreement for the Rinconcito de Esperanza Project between the Esperanza Peace & Justice Center and the Board for the public improvements. **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of the First Amendment to the Rinconcito de Esperanza Project Funding Agreement for the Rinconcito de Esperanza Project by and between the Esperanza Peace & Justice Center and the Board of Directors of Tax Increment Reinvestment Zone #30, attached hereto as **Exhibit A**, are hereby approved.
