*Whereas*, pursuant to Ordinance No. 2018-11-29-0930, the San Antonio City Council authorized a contract with BiblioCommons, Inc., for BiblioCore and BiblioMobile applications; and

*Whereas*, on February 10th, 2020, BiblioCommons Corp., a subsidiary of the Volaris Group Inc., purchased substantially all of the assets of BiblioCommons, Inc.; and

*Whereas*, through this acquisition by asset transaction, the BiblioCommons, Inc.'s existing contracts were assigned to BiblioCommons Corp., who adopted the existing Agreement with the City (the "Assignment"); and

*Whereas*, BiblioCommons, Corp. ("BiblioCommons" or "Vendor") and the City of San Antonio ("City" or "Subscriber") are parties to an Integration Agreement which began on December 1, 2018 and, as renewed and extended, terminates February 29, 2024 (the "Agreement"); and

*Whereas*, the Parties agree that the Agreement should be revised to extend the term for a five-year period; and

*Whereas*, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply, and

*Whereas*, this amendment is authorized with City Council approval pursuant to the section entitled "Amendments" in 006, General Terms & Conditions, of the above referenced contract, and the Contract is hereby amended as follows:

#### 1. AMENDMENTS

- A. BiblioSuggest. **Exhibit A**, RFO Section 004 - Specifications / Scope of Services, is hereby revised to add BiblioSuggest, a suggestion-tracking module that helps libraries automatically manage patron suggestions efficiently and equitably. Schedule "A-5", attached hereto and incorporated herein, is added to **Exhibit C**.

- B. **Exhibit A**, Section 005- Supplemental Terms & Conditions, Original Contract Term, is hereby revised to renew the Contract for a five-year period, beginning February 29, 2024, and ending February 28, 2029, and reads as follows:

Contract Term:

This Contract began on December 1, 2018, and terminates on February 28, 2029.

- C. **Exhibit D**, Price Schedule is revised to add Item 5, BiblioSuggest, for a one-time implementation fee of **\$1,250.00**. The following Annual Subscription Fees are hereby added to each Item as indicated below for annual subscription and continued maintenance and support:
