The City of San Antonio and the vendor identified above hereby agree to amend the contract identified above, as follows. This amendment is authorized pursuant to the section entitled “Amendments” in 006, General Terms & Conditions of the above referenced contract.

1. AMENDMENT

1.1 Section 004 – Specifications / Scope of Services, is revised to add turnkey installation of Forty (40) new pan tilt zoom (PTZ) cameras and two (2) Fixed Dome cameras identified during the site walks on October 18, 2023, and November 2, 2023. The cameras will have the ability to provide advanced video analytics including the following functionality: Intrusion, Loiter, Line crossing, Unattended object, Missing object, and Face detection. A dedicated workstation with client licensing shall be located in conference room 1.

- 1.1.1 City shall provide any special access equipment required to complete work.
- 1.1.2 **Project completion shall occur on or before April 26, 2024. Time is of the essence.**
- 1.1.3 Edge Analytics and Edge Redundant Video Storage Licensing on the Digital Video Manager is included.
- 1.1.4 Cameras include a 2 year manufacturer warranty.
