SUBJECT:

Traffic Code Update: Revisions to Chapter 19 of the City Code of San Antonio

SUMMARY:

An ordinance amending Chapter 19 of the City Code to update Traffic Control Schedules of Devices, adding locations citywide where new installations of traffic control devices have occurred, and removing locations citywide where devices have been altered or removed.

BACKGROUND INFORMATION:

This ordinance will update various Traffic Control Schedules of Devices established in Chapter 19, Section 68(b) of the City Code of Ordinances. All traffic control devices need to be present on these schedules to have effective enforcement. Types of traffic control devices include, but are not limited to, stop signs, traffic signals, parking restrictions and speed limit designations.

Approval of this ordinance will enable consistent enforcement of on-street traffic regulations and is a continuation of City Council policy to maintain efficient and safe traffic flow. These schedules are updated to reflect new traffic control device installations and/or the removal of such devices at specified locations. The last update to the Traffic Control Schedule of Devices was enacted on December 12, 2023.

ISSUE:

This ordinance amends the Traffic Control Schedules of Devices for the City of San Antonio, Texas established in Chapter 19, Section 68(b) of the City Code, to add 223 locations where new installations of traffic control devices have occurred, and to remove 72 locations where devices have been altered or removed.

TRAFFIC CONTROL SCHEDULES OF DEVICES

Approval of this ordinance amending Section 19-68(b) will enable consistent enforcement of on-street traffic regulations and is a continuation of City Council policy to maintain efficient and safe traffic flow. These schedules are updated to reflect new traffic control device installations and/or removal of such devices at specified locations. These device installations and/or removals are a result of traffic engineering evaluations which are typically prompted by citizen requests.

The following traffic control devices were ***added (included)*** since the previously enacted traffic code update on December 12, 2023.

Specific Titles included in this update are:

1. Full Traffic Signal Locations – (45 additional locations) [Schedule A(a) – update]
2. All Way Stops – (18 additional locations) [Schedule C(a) – update]
3. Cross Street Stop – (56 additional locations) [Schedule C(b) - update]
4. Maximum Speed Limit – (8 additional location) [Schedule E(a) – update]
5. Parking Prohibited at All Times, Including Sundays, and Holidays – (74 additional locations) [Schedule G(a) - update]
6. Stopping, Standing or Parking Prohibited Seven AM to Six PM, except Sundays and Holidays – (4 additional location) [Schedule H(e) - update]
7. Stopping, Standing or Parking Prohibited Seven AM to Nine AM and Two PM to Four PM School Days Only – (5 additional location) [Schedule H(i) - update]
8. Stopping, Standing or Parking Prohibited Seven AM to Nine AM and Two PM to Five PM School Days Only – (3 additional location) [Schedule H(k) - update]
9. Stopping, Standing or Parking Prohibited Ten PM to Six AM except Sundays and Holidays – (1 additional location) [Schedule H(l) - update]
10. Stopping, Standing or Parking Prohibited Nine PM to Six AM except Sundays and Holidays – (3 additional location) [Schedule H(n) - update]

11. School Speed Zones, School Crosswalks (Intersection), Seven AM to Nine AM and Two PM to Four PM, 20 mph, School Days Only, Cell Phone Use Prohibited – (1 additional location) [Schedule M(b) – update]

12. School Speed Zones, School Crosswalks (Intersection), Flashing Beacon, 20 mph, School Days Only, Cell Phone Use Prohibited – (3 additional location) [Schedule M(f) – update]

13. Commercial Loading Zone, 30-Minute Limit – (1 additional location) [Schedule P(a) – update]

14. Student Loading Zone, Seven AM to Nine AM and Two PM to Four PM School Days Only – (1 additional location) [Schedule P(l) – update]

4. Maximum Speed Limit – (3 removed location) [Schedule E(a) – update]

5. Parking Prohibited at All Times, Including Sundays, and Holidays – (9 removed location) [Schedule G(a) – update]

6. Stopping, Standing or Parking Prohibited Seven AM to Six PM – (1 removed location) [Schedule H(e) - update]

7. School Speed Zones, School Crosswalk (mid-block), cell phone use prohibited (2 removed location) [Schedule M(a) – update]

8. School Speed Zones, School Crosswalk (intersection), cell phone use prohibited (7 removed locations) [Schedule M(b) – update]

9. School Speed Zones, School Crosswalk (intersection), Seven AM to Nine AM, and Two PM to Four PM, 20 mph, school days only and cell phone use prohibited - (1 removed location) [Schedule M(d) – update]

10. School Speed Zones, School Crosswalks (Intersection), Flashing Beacon, 20 mph, School Days Only, Cell Phone Use Prohibited – (1 removed location) [Schedule M(f) – update]
