WHEREAS, the City of San Antonio ("City") and ParkHub, Inc. ("ParkHub" or "Vendor"), entered into an agreement to provide the Convention & Sports Facilities Department (CSF) with parking lot point-of-sale services for the Alamodome pursuant to Ordinance 2017-12-14-0988, which, as assigned and renewed and extended, terminates on December 14, 2024 (hereinafter the "Agreement"); and

WHEREAS, City wishes to extend the Agreement for an additional one-year period and add the option for the City to renew for a one-year term in anticipation of consolidating the parking needs of CSF and the Center City Development Office (CCDO) and requires time to issue a solicitation; and

WHEREAS, ParkHub provided an offer for continued application access and software maintenance; **NOW THEREFORE**: This Agreement is hereby amended as follows:

1. CHANGE ORDER

- a) Article 2.0, Term, is hereby revised to extend the term of the Agreement for a one-year period, beginning December 15, 2024, and ending December 14, 2025. The City shall have the option to renew for one, additional one-year period without additional City Council approval. Renewals shall be in writing and signed by Director, without further action by the San Antonio City Council, subject to and contingent upon appropriation of funding therefor.

Monthly Per Device Fee: \$5.00, "Per Device Fee" - this is the per terminal charge (#) based on the number of ParkHub devices that are capable of processing a credit card transaction.
