Whereas, pursuant to Ordinance No. 2018-11-15-0903, the City of San Antonio (“City”) entered into a contract with Passport Labs, Inc., for a mobile parking application for a period of two years, with three one-year renewal options (the “Agreement”); and

Whereas, the Parties agree to extend the term of the Agreement for an additional one-year period beginning November 20, 2023 and ending November 20, 2024, with the option to renew for an additional one-year period for an increased convenience fee for users in the amount of \$0.25; and

Whereas, hereby issues this change order to the above referenced contract pursuant to Texas Local Government Code §252.048, and Ordinance No. 2011-12-08-1014, passed and approved December 8, 2011. This contract is hereby amended as follows:

1. CHANGE ORDER

1.1 Article 2.0 Term, is revised to add:

The term of this Agreement shall continue for an additional one one-year period beginning November 20, 2023 and ending November 20, 2024, with the option for the City to renew under the same terms and conditions for an additional one-year period ending November 20, 2025, without further action by the San Antonio City Council, subject to and contingent upon appropriation of funding therefor.

1.2 The City agrees to pay Passport Labs, Inc., a per transaction MPP Convenience Fee Passed through to Parking Customers in the amount of \$0.25.

2. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.


3. ENTIRE AGREEMENT
