The City Council convened a regular meeting in the Norma S. Rodriguez Council Chamber in the Municipal Plaza Building beginning at 11:10 a.m. City Clerk Debbie Racca-Sittre took the Roll Call noting a quorum with the following Council Members present:

PROCEDURAL

1. Invocation

The invocation was delivered by Father Judge Offor of St. Paul's Catholic Church, guest of Councilmember Alderete Gavito, Council District 7.

2. Pledge of Allegiance

Mayor Nirenberg led the assembly in the Pledge of Allegiance.

3. Approval of minutes for the City Council meetings of March 19, 2025 and March 20, 2025.

Councilmember Alderete Gavito announced Carboard Kids Reveal Day for 2025, a campaign by ChildSafe, Inc. to draw attention to April 2025 as Child Abuse Prevention Month.

ACTION ITEM FOR STAFF BRIEFING

PUBLIC COMMENT:

Marcus Dovalina, Laura Molinar, Ariana Rodriguez, Kate Sanchez, Yaneth Flores, Erika Galindo, Mohammad Rasool, Dominique Huerta, Brielle Insler, Ruby Jimenez, and Jessica Solis spoke in support of the Item.

Dr. Tim Westley, Rolando Pablos, Mike Knuffke, Robert Gonzalez, Patrick Von Dohlen, Paul Comeaux, Betty Eckert, Susan Barnes, Raymond Zavala, and Grant Moody spoke in opposition to the Item.

City Attorney Andy Segovia reminded speakers that it was inappropriate to turn their comments into campaign speeches as several had mentioned that they were running for Mayor.

DISCUSSION:

Councilmember Cabello Havrda declared that this was a fight for women's lives as families were being forced into impossible situations and San Antonio would stand up for the reproductive health of women when the State was failing. She noted that this was about dignity, autonomy, and healthcare for real people. Councilmember Cabello Havrda stated that this was about women's lives being in danger when they needed to expel a fetus that had died or needed treatment for a high-risk pregnancy. She noted that women were being treated as criminals simply for having a miscarriage. Councilmember Cabello Havrda noted that Budget surveys indicated the need for protecting our community, public safety, and health, which the Reproductive Justice Fund included.

Councilmember Courage did not support using the City Council's time and resources today to discuss abortion and suggested that two or three liberal-minded Councilmembers today wanted to bring up a divisive issue that would not bring confidence to our government. Councilmember Courage recommended reviewing what should be within the scope and realm of City Government and did not feel helping people travel out of state to get an abortion would qualify as basic City services. He asked if this was a one-time allocation or if it would be an ongoing commitment by the City.

Councilmember Kaur commended Councilmember Cabello Havrda's leadership on the issue noting that this was a missing piece of reproductive justice funding. She supported allocation of funding for women's health every year. Councilmember Kaur stated that she was tired of men making decisions for women. She quoted that maternal mortality rates had increased by over 50% since the abortion ban had come into effect and it was even higher for low-income individuals and women of color. She felt that this was a new form of redlining and she supported women's rights for all women in the City and not just for the wealthy.

Councilmember Alderete Gavito stated that she was pro-choice but did not think her personal feelings should influence what the City did with its money. She noted that San Antonio needed money for basic services such as streets, drainage, and public safety and noted that the lawsuits would cost the City even more. Councilmember Alderete Gavito mentioned that she personally donated to nonprofits that helped support women's rights, but the City should not provide access to abortion.

Councilmember Pelaez did not support the funding because it would be of great cost. He supported the work of nonprofits and agreed that abortion was healthcare, but stated that the State was the place where this should be fought. Councilmember Pelaez disagreed that \$100,000 would save lives because none would be spent as the funding and the program would be tied up in courts for years. Councilmember Pelaez commented that he was monitoring Senate Bill (SB) 33 filed by Texas State Senator Donna Campbell that would make this illegal and it was likely to pass. He stated that this was not a good use of public funds or a real display of leadership. Councilmember Pelaez did not think this was a binary choice between supporting women or not.

Segovia indicated that the law was very fluid and his office would defend the City against any lawsuits.

Councilmember Whyte warned that this was heading down a dark road. He framed the issue as being about the proper role of City Government and what should be done with citizens' tax dollars as money was extremely tight and there were so many issues such as infrastructure, public safety, and housing that should be funded instead. Councilmember Whyte stated that streets, sidewalks, and drainage were the number one call from residents and 22% of the roads City-wide were in poor or failing condition. He noted the crime statistics around the City and stated that funding should go to those

needs rather than this Item. Councilmember Whyte vowed to continue to work with his fellow Councilmembers on their priorities but asked his colleagues to reconsider voting for the Item as it was not what taxpayers wanted.

Segovia reiterated that there was nothing before City Council today that violated local, State, or Federal Laws.

Councilmember Viagran stated that as an individual that studied women's history at a conservative college and an individual with cancer that could affect her reproductive organs, women had not been respected or prioritized by the medical community or this nation for their health and the autonomy of their own bodies. Councilmember Viagran supported Councilmember Castillo's plan to create a Reproductive Justice Fund and stated that women in the City needed support and help as historically women were treated as second-class citizens. She asked City Council to do for generations what had not been done to prioritize the health of women.

Councilmember Viagran noted that the funding was for downstream services and if no agency put forth a proposal for out of state abortion travel, the funding was still needed. She noted that her doctors dismissed her because she was a woman and as an educated elected official, she could not imagine what would happen to poorer, less educated women. Councilmember Viagran asserted that this was a fund that would help women live. For years, according to Councilmember Viagran, women had been treated as second class citizens and this only helped them.

Councilmember McKee-Rodriguez commented that in July, he and his husband would be welcoming a new baby into their home. He noted that the City funded some projects that helped the wealthiest in our communities and this fund would go to help some of the least wealthy. Councilmember McKee-Rodriguez commented that abortion could be a necessary life-saving treatment. He agreed that this would not normally be a local issue, but our State was making our residents unsafe. Councilmember McKee-Rodriguez requested a comprehensive review of practices and policies so that we could lead on reproductive justice.

Councilmember McKee-Rodriguez stated that the funding formula for streets was changed in 2022 to provide more equitable funding, spay neuter hubs for animals were being opened, the Integrated Community Safety Office opened, affordable housing was under construction right now, and funding was being spent to sweep away homeless encampments and all their belongings.

Councilmember Castillo suggested that investing in San Antonio's healthcare assets was important and the waste of taxpayer money was really in the developer giveaways or relocation of facilities to build a new \$2 billion basketball stadium. Councilmember Castillo highlighted that it was the responsibility of City Council to provide for the basic necessities of life for residents as stated in the City Charter. She declared healthcare to be a basic human right and stated that the funding including travel to access an abortion was a part of the City's SA Forward Public Health Strategic Plan.

Councilmember Castillo asked if the \$100,000 fund would be diverted to support legal fees. Segovia stated that there was a separate account to cover legal fees.

Councilmember Courage asked where the \$100,000 would come from. City Manager Walsh stated that non-personnel funding would be reallocated from the Metro Health Department. Councilmember Courage wanted to ensure that no other health services would be cut.

Councilmember Kaur commented that the City Council had never let City policies be based on the fear of lawsuits. She noted that this was a political decision, they should own it. Councilmember Kaur agreed that 30% of Council District 1 streets were failing and \$100,000 would maybe get a quarter of a block of sidewalk filled versus saving a hundred lives.

Councilmember Whyte stated that \$100,000 could fund another police officer. He asked Assistant City Manager Jeff Coyle about SB 33. Coyle reported that it was in committee and was designated as a priority bill by the Lieutenant Governor. Councilmember Whyte noted that the Republicans in the Texas Legislature were overwhelmingly in support of the bill. He was concerned that spending money to defend lawsuits was money that came directly out of the pockets of our taxpayers, and this was a certain defeat because SB 33 was almost certain to pass.

Councilmember Viagran asked Coyle if he could predict for sure that SB 33 would become law. Coyle indicated that he could not predict what the legislature would do. Councilmember Viagran noted that the Lieutenant Governor had 40 priority bills. She noted that women heads of households were the most impoverished in San Antonio and anything that could be done to help women with their healthcare would be welcomed. Councilmember Viagran suggested that saving women's lives was a good return on investment.

Councilmember Cabello Havrda stated that she was not afraid of a lawsuit if it meant the City saved women's lives and did not appreciate hiding behind tax dollars.

Councilmember McKee-Rodriguez asked when SB 33, if passed, would go into effect and if the funding were passed today by City Council when could the money be spent. Coyle stated that the law would become effective on September 1, 2025. Dr. Claude Jacob, Director of Metro Health, stated that the funding would be expected to be under contract by June 2025. Coyle reported that the bill allowed residents to bring a complaint and funding could halt, however, he was not sure if they could get back money already spent. Segovia indicated that contracts would be written to ensure compliance with the law. City Manager Walsh stated that if the Item was approved, staff would go through the expedited procurement and usually services would be under reimbursement; funding was not provided up-front. City Manager Walsh noted that the services would depend upon the proposals received.

Mayor Nirenberg noted the strident rhetoric and debate. He mentioned that there was an unrelenting attack on women's healthcare decisions in the State and he trusted women and doctors over politicians who thought they knew better.
