The City of San Antonio (City) and the vendor identified above (Vendor) hereby agree to amend the contract identified above, as follows. This amendment is authorized with City Council approval pursuant to the section entitled “Amendments” in 006, General Terms & Conditions of the above referenced contract (hereinafter “the Contract”).

1. AMENDMENTS

1.1 Section 005 – SUPPLEMENTAL TERMS & CONDITIONS, Original Contract Term, is revised to extend the term for an additional five-year period beginning August 1, 2024, and ending July 31, 2029, as follows:

Contract Term.

This contract began on August 1, 2022, and ends on July 31, 2029.

1.2 Attachment A – Price Schedule is revised to add the following Item 3 and Item 4 for the period beginning August 1, 2024, and ending July 31, 2029:

- Item 3: Guardian Electronic I-9 and E-Verify \$27,000 annually
- Item 4: Price Per Excess I-9 \$9.95 for each I-9 over 3,500

1.3 Attachment A- Price Schedule is revised to delete Item 1 and Item 2.

2. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.

3. ENTIRE AGREEMENT

This contract, as amended, embodies the complete agreement of the parties hereto with regard to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.
