**ORDINANCE**

**APPROVING AN INSURANCE PROPERTY DAMAGE RELEASE  
AGREEMENT BETWEEN THE OHIO SECURITY INSURANCE  
COMPANY (DBA LIBERTY MUTUAL INSURANCE) AND THE  
CITY OF SAN ANTONIO TO ACCEPT FUNDS IN AN AMOUNT  
NOT TO EXCEED \$89,005.91 FOR PROPERTY DAMAGE  
INCURRED AT STONEWALL AVENUE RESULTING FROM  
WORK COMPLETED FOR NETSPAN CORPORATION AND  
FOREMOST TELECOMMUNICATIONS CORPORATION. FUNDS  
WILL BE DEPOSITED INTO THE STORM WATER OPERATING  
FUND**

**WHEREAS**, as part of FY 2023 Corrugated Metal Pipe (CMP) Rehabilitation program the contractor, Lewis Concrete Restoration (LCR), rehabilitated a storm drainage CMP along Stonewall Avenue., which began in December 2022, and was completed in February 2023; and

**WHEREAS**, as customary, to confirm the rehabilitation was completed successfully, the contractor, LCR, televised the pipe for inspection, during which it was identified that a utility intrusion occurred near Stonewall Avenue between Pleasanton Road and South Flores Street; and

**WHEREAS**, the City of San Antonio Right of Way division contacted the utility contractor, Foremost Telecommunications Corporation (Foremost) in March 2023, and an insurance claim was filed with the Ohio Security Insurance Company (d/b/a Liberty Mutual Insurance); and

**WHEREAS**, on September 10, 2024, an agreement on the insurance claim was reached that the insurer would reimburse the City for rehabilitation and repair for Stonewall Avenue; and

**WHEREAS**, repair work has been completed by the City's CMP contractor and the amount reimbursed from the proposed insurance claim will be programmed towards future CMP projects; and

**WHEREAS**, this ordinance approves an Insurance Property Damage Release agreement between the Ohio Security Insurance Company (d/b/a Liberty Mutual Insurance) and the City of San Antonio to accept funds in an amount not to exceed \$89,005.91 for property damage incurred at Stonewall Avenue resulting from work completed for Netspan Corporation and Foremost Telecommunications Corporation; and

**WHEREAS**, his ordinance reimburses the City for the repair work completed by the City's FY 2023 Corrugated Metal Pipe (CMP) Rehabilitation program contractor that originally completed

the FY 2023 CMP Stonewall Avenue project funded by Storm Water Operating Funds; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to approve an Insurance Property Damage Release agreement between the Ohio Security Insurance Company (d/b/a Liberty Mutual Insurance) and the City of San Antonio to accept funds in an amount not to exceed \$89,005.91 for property damage incurred at Stonewall Avenue resulting from work completed for Netspan Corporation and Foremost Telecommunications Corporation.

**SECTION 2.** Funds received for this ordinance will be deposited in Fund 29070000, Internal Order 223000000071 and General Ledger Account 6301130.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
