

**INTEGRATION AGREEMENT
FOR
ANNUAL CONTRACT FOR LANDSCAPING SERVICES FOR RADIO TOWER SITES
FOR ITSD**

**REQUEST FOR COMPETITIVE SEALED PROPOSAL (“RFCSP”)
NO. 23-028; RFX NO. 6100015889**

This Agreement is entered into by and between the **City of San Antonio**, Texas, a home-rule municipal corporation (“City”) acting by and through its Director of Finance or said Director’s designee (“Director”), pursuant to Ordinance No. _____ passed and approved on the _____ day of _____, 20___, and **La Med Facilities Maintenance, Inc.** (“La Med” or “Vendor”). City and Vendor may be referred to herein collectively as the “Parties”.

The Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described.

1.0 CONTRACT DOCUMENTS

The terms and conditions for performance and payment of compensation for this Agreement are set forth in the following contract documents, true and correct copies of which are attached hereto and fully incorporated herein for all purposes, and shall be interpreted in the order of priority as appears below:

- a. This Integration Agreement;
- b. City’s RFCSP No. 23-028; RFX No. 6100015889, including all exhibits, attachments and addendums thereto (**Exhibit A**);
- c. Vendor’s Price Schedule, including Best and Final Offer dated May 19, 2023, hereinafter the “Price Schedule” (**Exhibit B**); and
- d. Vendor’s Proposal in response to RFCSP No. 23-028; RFX No. 6100015889 (**Exhibit C**).

2.0 TERM

2.1 Contract Term. This contract shall begin upon the effective date of the ordinance awarding the contract and terminate on March 31, 2026, unless sooner terminated in accordance with the provisions of this Agreement.

2.2 Renewals. At City’s option, this Contract may be renewed under the same terms and conditions for two (2) additional, one (1) year periods. Renewals shall be in writing and

signed by Director, without further action by the San Antonio City Council, subject to and contingent upon appropriation of funding therefor.

2.3 Temporary Short-Term Extensions.

City shall have the right to extend this contract under the same terms and conditions beyond the original term or any renewal thereof, on a month-to-month basis, not to exceed three months. Said month to month extensions shall be in writing, signed by Director, and shall not require City Council approval, subject to and contingent upon appropriation of funding therefor.

3.0 NOTICE

Except where the terms of this Agreement expressly provide otherwise, any election, notice or communication required or permitted to be given under this Agreement shall be in writing and deemed to have been duly given if and when delivered personally (with receipt acknowledged), or three (3) days after depositing same in the U.S. mail, first class, with proper postage prepaid, or upon receipt if sending the same by certified mail, return receipt requested, or upon receipt when sent by a commercial courier service (such as Federal Express or DHL Worldwide Express) for expedited delivery to be confirmed in writing by such courier, at the addresses set forth below or to such other address as either party may from time to time designate in writing.
