

**ORDINANCE**

**APPROVING THE FOLLOWING AT-LARGE APPOINTEES TO THE AIRPORT ADVISORY COMMISSION FOR THE REMAINDER OF AN UNEXPIRED TERM OF OFFICE TO EXPIRE ON MARCH 18, 2026: BAILEY GORIN (AVIATION INDUSTRY), JEFFREY FAIR (BUSINESS COMMUNITY), JUANITA SEPULVEDA (BUSINESS COMMUNITY), ROGER DILLARD (COMMUNITY), WILLIAM GARRISON (COMMUNITY), AND WAIVING THE TERM LIMIT REQUIREMENT FOR THE FOLLOWING APPOINTMENTS: DEBORAH OMOWALE JARMON (TRAVEL & TOURISM INDUSTRY), MARK FESSLER (AVIATION INDUSTRY), EARL JACKSON (FEDERAL AVIATION ADMINISTRATION) AND JOHN GRISELL (GROUND TRANSPORTATION).**

**WHEREAS**, on March 19, 2024, the Transportation and Infrastructure Committee met and interviewed thirteen applicants for nine at-large seats for appointment to the Airport Advisory Committee; and

**WHEREAS**, the Committee recommended appointment of Bailey Gorin, Jeffrey Fair, Juanita Sepulveda, Roger Dillard, William Garrison, Deborah Omowale Jarmon, Mark Fessler, Earl Jackson, and John Grisell to the Airport Advisory Committee for the remainder of unexpired terms of office expiring on March 19, 2026; and

**WHEREAS**, the Committee also recommended waiving the term limit requirement for Deborah Omowale Jarmon, Mark Fessler, Earl Jackson, and John Grisell for this appointment; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Bailey Gorin, Jeffrey Fair, Juanita Sepulveda, Roger Dillard, William Garrison, Deborah Omowale Jarmon, Mark Fessler, Earl Jackson, and John Grisell are appointed for the remainder of unexpired terms of office expiring on March 19, 2026 to the Airport Advisory Commission.

**SECTION 2.** The term limit requirement for Deborah Omowale Jarmon, Mark Fessler, Earl Jackson, and John Grisell is waived.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
