Re: S.P. No. 20250000352 – Request for an encroachment permit for an entrance monument sign above and across Quarry Park Public Right-of-Way

Dear Mr. Hartman:

With reference to the captioned project, please be advised that the City of San Antonio has now completed the canvassing process and will recommend approval of the request subject to the following conditions:

CPS ENERGY: 1) Pole number 2896677 will have to be relocated if the proposed sign is going to be installed at the same location to avoid conflict at the customer's expense. If not, the proposed sign will have the correct amount of clearance from the neutral and primary conductors of pole number 2896677. Pole number 2875578 and guy wires will need to stay at their exact locations due to Wurzbach Pkwy Hwy Crossing. 2) Petitioner must call Texas 811 and verify location of all Gas Facilities.

DIVERSITY, EQUITY, INCLUSION & ACCESSIBILITY DEPARTMENT: The existing sidewalk should not be reduced below 5 feet.

SAN ANTONIO FIRE DEPARTMENT: Height must be at least 13 feet 6 inches per 2021 IFC 503.2.1.

SAWS: SAWS has an existing water line installed within Quarry Park ROW. No permanent structure can be built over our infrastructures. See attached Geocortex Map and As-Built.

PUBLIC WORKS:

ENVIRONMENTAL SERVICES: It is the Petitioner's responsibility to conduct their own due diligence for this area. The City does not warranty that environmental impacts are not to be encountered when disturbing the land. The City shall not bear any financial burden related to environmental impacts (if any) encountered during the disturbance of the land. If environmental impacts are encountered, it is the Petitioner's responsibility to notify the City and the appropriate regulatory agencies of the issue.

TRAFFIC ENGINEERING AND OPERATIONS: If at any time the vertical clearance between any part of the roadway and structure falls below 20 feet-0 inches, a sign shall be posted on the structure providing the vertical clearance in compliance with the Texas Manual on Uniform Traffic Control Devices (TxMUTCD).

Morgan's plans to construct an entrance monument sign above and across Quarry Park Public Right-of-Way.

The fee established for this public right-of-way encroachment is \$1,100.00, which includes \$500.00 for the initial 10-year term, \$500.00 for the second 10-year term, plus \$100.00 for the recording fees. This total fee will be due and payable to the City of San Antonio prior to City Council consideration.

This Letter of Agreement is being offered by City of San Antonio only to the petitioner named below and will expire thirty (30) days after date of issuance unless a specific extension is requested by the petitioner and granted by the City.


