The City Council convened a regular meeting in the Norma S. Rodriguez Council Chamber in the Municipal Plaza Building beginning at 9:06 AM. City Clerk Debbie Racca-Sittre took the Roll Call noting a quorum with the following Council Members present:

PROCEDURAL

1. Invocation

The invocation was delivered by Pastor David Cameron of Refuge Church, guest of Councilmember Viagran, Council District 3.

2. Pledge of Allegiance

Mayor Nirenberg led the assembly in the Pledge of Allegiance.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg proclaimed February to be Black/African American Heritage Month and invited the Director of the San Antonio African American Community Archives and Museum Deborah Omowale Jarmon to speak regarding the 2024 Theme “African Americans and the Arts.” Councilmember McKee-Rodriguez, the first Black and openly gay elected official in Texas, spoke in support of Black History Month. Mayor Nirenberg and Councilmembers Kaur and Alderete Gavito spoke in support of the Proclamation and all the events for the month.

Mayor Nirenberg recognized the 75th Annual San Antonio Stock Show and Rodeo and proclaimed February 8-5, 2024 to be official Rodeo Season in San Antonio.

Councilmember Viagran congratulated the association on achieving 75 years and awarding over \$243 million in scholarships since 1949. She invited members of the association to speak. Mayor Nirenberg and Councilmembers Kaur, Rocha Garcia, Alderete Gavito, Courage and Whyte spoke in support of the Proclamation.

Mayor Nirenberg proclaimed February 7, 2024 to be National Black HIV/AIDS Awareness Day and invited representatives from Black Effort Against the Threat of AIDS also known as B.E.A.T. AIDS Coalition to speak. Mayor Nirenberg and Councilmembers McKee-Rodriguez and Viagran spoke in support of the Proclamation.

9. **2024-02-01-0087**

Ordinance adding a City Council Code of Conduct to the City Code of San Antonio that outlines general standards of conduct and a process for reporting and enforcement. [Andy Segovia, City Attorney]

The Item was pulled for individual consideration by Councilmember Castillo.

PUBLIC COMMENT:

Jack Finger spoke in opposition to the requirement to disclose romantic relationships to the City Manager noting he should not serve as a priest or judge. He also opposed the policy allowing breastfeeding mothers to have a place to express milk.

Former District 1 City Councilmember Mario Bravo spoke in opposition to the Code of Conduct contending that voters should decide if a member deserved to be removed and recommended if the Code of Conduct went forward, to spell out the rights of the accused.

DISCUSSION:

Councilmembers Kaur, Rocha Garcia, Alderete Gavito and Whyte spoke in support of the Code of Conduct.

Councilmember Castillo expressed concern that some areas of the policy needed to be defined in order to ensure that the Code of Conduct did not result in censorship and infringe on United States First Amendment rights. City Attorney Segovia stated that all First Amendment Rights would supersede the Code of Conduct.

Councilmember Castillo opposed the section that allowed the Mayor to not follow Robert's Rules of Order. She added that there was a recall process outlined in the City Charter so that voters could weigh in on conduct. Councilmember Castillo provided a list of local, State and Federal elected officials that were targeted under similar policies for their political beliefs.

Councilmember Courage asked the City Attorney if the new Code of Conduct would address a Councilmember that was involved in an alcohol or drug violation outside of City Council hours such as a Driving Under the Influence (DUI) charge as well as the definition of moral turpitude. City Attorney Andy Segovia noted that moral turpitude was difficult to define and the facts and circumstances of each case would need to be considered.

Councilmember Courage asked whether the following might be covered under the new Code of Conduct: demeaning another Councilmember either intentionally or inadvertently through Social Media, a failure to perform their duty or misdirecting City resources as well as a Councilmember acting in opposition to City policies to the detriment of the City. City Attorney Segovia stated that each case would be reviewed individually but misdirecting City resources was prohibited under administrative directives and acting adversely to the City was a current prohibition. Councilmember Courage supported the Code of Conduct because the community expected City Council to police itself.

Councilmember McKee-Rodriguez expressed concern that the Code of Conduct was vague and there was no way to determine how a future City Council could interpret such a broad and general document.

Councilmember Viagran clarified that future City Councils were free to repeal or amend the Code of Conduct. She saw the document as a tool to help the City Council conduct its business and

hoped it would never be used for political gain or retaliation.

Councilmember Castillo suggested a review of Labor Union Codes of Conduct and expressed concern that there had been little opportunity for public comment since the Item was posted on the agenda on Friday.

Councilmember Whyte expressed concern that it was a slippery slope and highlighted Section 2.2.1 of the City Code regarding a Councilmember making a derogatory remark about another Councilmember which could be a potential violation. Councilmember Whyte cautioned against frivolous complaints that would cost time and money.

Councilmember Rocha Garcia supported having a public dialogue on the Code of Conduct. She mentioned that over 40 revisions to the City's Ethics Code were approved by City Council in 2016 which was proof that Ordinances could be updated as needed; noting that the Code of Conduct was a good first start.

Councilmember Courage recommended reviewing the Code of Conduct to ensure that no Councilmember took an opposing legal side that could cost the City money.

Councilmember Viagran requested clarification on how this might be added. City Attorney Segovia confirmed that this was already something that the City Council could address even without a City Council Code of Conduct.

Councilmember McKee-Rodriguez expressed concern that elected officials might be politically silenced.

Mayor Nirenberg clarified that the Code of Conduct did not create new authorities or responsibilities for the Mayor, City Council or the City Manager. He noted that integrity and professionalism was an expectation of the public and they existed with or without a written Code of Conduct. Mayor Nirenberg noted that the proposed Code of Conduct would not alter past disciplinary actions taken by the City Council. He stressed that the Code of Conduct did not create a new judicial authority and each Councilmember retained their right to vote.

Mayor Nirenberg highlighted Section 2-21(b) and stated that nothing in the proposed Code of Conduct was really new. Mayor Nirenberg supported the Code of Conduct noting that these were expectations of the community.
