Rachel Belinsky and Hugh Reasonover spoke in opposition to the Items citing traffic concerns and a narrow bridge. Richard Adam, Resident of Forest Crest Neighborhood submitted a letter stating the same concerns.

Vanessa Rodriguez representing the owner spoke in support of the Item.

DISCUSSION:

Councilmember Pelaez spoke in support of the project and the need for additional housing. He acknowledged the bridge needed to be improved and suggested it could be included in the 2027 Bond. Councilmember Pelaez added that there would be a full left turn lane and other improvements made to Camp Bullis Road and the developer had

agreed to balanced restrictive covenants. Councilmember Pelaez pledged to work with the school on the bus stops.

Mayor Nirenberg noted that Camp Bullis had submitted a letter and the developer had agreed to the restrictions required by the military.

Councilmember Viagran supported the residents being involved in traffic planning and recommended seeking federal funds for the street/bridge improvements and did not think they should wait for the 2027 Bond.
