

FIELD NOTE DESCRIPTION

Variable Width Temporary Construction Easement
0.022 of One Acre of Land (958 sq. ft.)

Being a 0.022 acre (958 square feet) tract of land, situated in San Antonio, Bexar County, Texas; and being a portion of Lot 1, New City Block 17726, Classen Road Subdivision as recorded in Volume 9590, Page 151, Deed and Plat Records, Bexar County Texas, as conveyed to Garrett Holdings, LLC in Volume 15210, Page 841 of the Official Public Records of Bexar County, Texas; said 0.022 acres being more particularly described by metes and bounds as follows with all bearings being referenced to the North American Datum 1983, Texas Coordinate System, South Central Zone:

Beginning, at a set 1/2-inch iron rod with Stantec Cap on the Northeast right-of-way line of Classen Road (variable width R.O.W.) for the Northwestern corner of said Lot 1 and the Southwesterly corner of Lot 121, Block 1, New City Block 17726, Classen Offices Subdivision as recorded in Volume 9673, Page 174, Deed and Plat Records of Bexar County, Texas;

Thence, N 45° 31' 47" E, 5.40 feet, along the common line of Lots 1 and 121, to a point for the Northeast corner of the herein described tract of land;

Thence, S 59° 13' 51" E a distance of 131.99 feet, to a point;

Thence, N 45° 22' 41" E a distance of 7.57 feet, to a point;

Thence, along the arc of a curve to the right, having a chord of S 66° 50' 34" E, 39.05 feet, a radius of 902.37 feet and a central angle of 02° 28' 46", a distance of 39.05 feet to a point along the common line of Lots 1 and Lot 34, Block 1 of the Ely One Subdivision Unit 2, as recorded in Volume 9576, Page 61, Deed and Plat records of Bexar County, Texas;

Thence, S 45° 19' 40" W, 9.20 feet, along the common line of Lot 1 and Lot 34, Block 1, New City Block 17726, Ely One Subdivision, Unit 2 as recorded in Volume 9576, Page 61 Deed and Plat Records Bexar County, Texas, to a set 1/2-inch iron rod with Stantec Cap for corner;

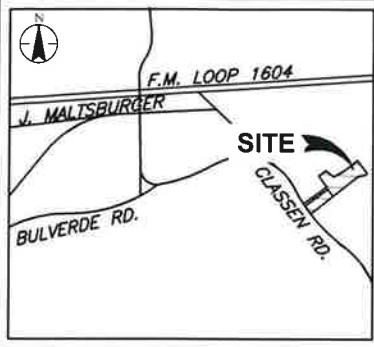
