The Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described.

# ARTICLE 1 CONTRACT DOCUMENTS

The terms and conditions for performance and payment of compensation for this Agreement are set forth in the following contract documents, true and correct copies of which are attached hereto and fully incorporated herein for all purposes, and shall be interpreted in the order of priority as appears below:

- a. This Integration Agreement;
- b. City's RFCSP No. 6100018137; 24-103, including all exhibits, attachments and addendums thereto (hereinafter, the "RFCSP") (**Attachment A**);
- c. Vendor's Price Schedule submitted in response to City's RFCSP No. 6100018137; 24-103 (hereinafter, the "Price Schedule") (Attachment B); and
- d. Vendor's Proposal submitted in response to RFCSP No. 6100018137; 24-103, (hereinafter, the "Vendor's Proposal") (Attachment C).

### ARTICLE 2 TERM

- 2.1 <u>Original Contract Term</u>. This Agreement shall begin upon the effective date of the ordinance awarding the contract or December 1, 2024, whichever is later. This Agreement shall terminate on December 31, 2027, unless sooner terminated in accordance with the provisions of this Agreement.
- 2.2 <u>Renewals</u>. At City's option, this Agreement may be renewed under the same terms and conditions for two (2) additional, one (1) year periods. Renewals shall be in writing and

- signed by the Director, without additional City Council approval, subject to and contingent upon appropriation of funding therefor.
- 2.3 <u>Temporary Short-Term Extensions</u>. City shall have the right to extend this contract under the same terms and conditions beyond the original term or any renewal thereof, on a month-to-month basis, not to exceed three months. Said month to month extensions shall be in writing, signed by Director, and shall not require City Council approval, subject to and contingent upon appropriation of funding therefor.

### ARTICLE 3 NOTICE

Except where the terms of this Agreement expressly provide otherwise, any election, notice or communication required or permitted to be given under this Agreement shall be in writing and deemed to have been duly given if and when delivered personally (with receipt acknowledged), or three (3) days after depositing same in the U.S. mail, first class, with proper postage prepaid, or upon receipt if sending the same by certified mail, return receipt requested, or upon receipt when sent by a commercial courier service (such as Federal Express or DHL Worldwide Express) for expedited delivery to be confirmed in writing by such courier, at the addresses set forth below or to such other address as either party may from time to time designate in writing.

## ARTICLE 4 REINSTALLATION SERVICES UPON DECOMMISSIONING

Parties acknowledge and agree that as stated in **Attachment A**, RFCSP Section 004 – Specifications / Scope of Services, DSS shall provide reinstallation of factory glass and side windows upon decommissioning of a vehicle, upon request by City. Reinstallations done by DSS will be completed on a time and materials basis. City shall pay DSS labor at the applicable hourly rate in **Attachment B**, Price Schedule Item 1, and parts in accordance with the percent markup over manufacturers' wholesale costs in **Attachment B**, Price Schedule Item 2. Should City request reinstallation services, DSS will provide a deliverables-based quote with a stated maximum cost, based on the hourly rate and the projected number of hours it will take to complete the work, quoted as a "not to exceed" fee.

## ARTICLE 5 ENTIRE AGREEMENT

This Agreement, together with its exhibits, if any, constitutes the final and entire agreement between the parties hereto and contains all of the terms and conditions agreed upon. No other agreements, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind the parties hereto, unless the same are in writing, dated subsequent to the date hereto, and duly executed by the parties.
