

ORDINANCE

APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED COST OF \$363,548.00 ANNUALLY, INCLUDED IN THE RESPECTIVE DEPARTMENT'S FY 2024 ADOPTED BUDGET: (A) ARCHIE SUPPLY, LLC, FOR DECORATIVE METAL PICNIC TABLES FOR THE PARKS AND RECREATION DEPARTMENT; (B) GEAR CLEANING SOLUTIONS, LLC, FOR BUNKER GEAR MAINTENANCE & REPAIR SERVICES FOR THE SAN ANTONIO FIRE DEPARTMENT; AND (C) AUTO CHLOR SERVICES, LLC, FOR EXTRACTORS AND DRYERS FOR THE SAN ANTONIO FIRE DEPARTMENT.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, this ordinance approves contracts with: (A) Archie Supply, LLC, for decorative metal picnic tables for the Parks and Recreation Department; (B) Gear Cleaning solutions, LLC, for bunker gear maintenance and repair services for the San Antonio Fire Department; and (C) Auto Chlor Services, LLC, for extractors and dryers for the San Antonio Fire Department; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; and

WHEREAS, approval of this ordinance authorizes one low bid contract and two contracts on the basis of public health or safety; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The contracts with: (A) Archie Supply, LLC, for decorative metal picnic tables for the Parks and Recreation Department; (B) Gear Cleaning solutions, LLC, for bunker gear maintenance and repair services for the San Antonio Fire Department; and (C) Auto Chlor Services, LLC, for extractors and dryers for the San Antonio Fire Department, are hereby approved, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. Copies of the bid tabulation sheets and contracts are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funds will be encumbered upon issuance of purchase orders, and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2024 budget, and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

SECTION 3. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
