

### FIELD NOTE DESCRIPTION

Variable Width Right-of-Way Acquisition (fee simple)  
0.0958 of One Acre of Land (4,171 sq. ft.)

Being a 0.0958 acre (4171 square feet) tract of land, situated in San Antonio, Bexar County, Texas; and being a portion of a called 244.5 acre tract as conveyed to D., J., R., & G. Pape and recorded in Volume 18375, Page 309, Official Public Records of Bexar County, Texas; said 0.0958 acres being more particularly described by metes and bounds as follows with all bearings being referenced to the North American Datum 1983, Texas Coordinate System, South Central Zone:

**Beginning**, at a set 1/2-inch iron rod with Stantec Cap for corner on the Northerly line of said remaining portion of a called 244.5 acre tract and the Southerly line of Lot 34, Block 1, New City Block 17726, Ely One Subdivision, Unit 2 as recorded in Volume 9576, Page 61 of the Deed and Plat Records of Bexar County, Texas; from which a point on the Northerly right-of-way line of Classen Road Bears S 45° 24' 32" W, 3.63 feet;

**Thence**, along the arc of a curve to the right, having a chord of S 68° 59' 46" E, 363.92 feet, a radius of 1141.25 and a central angle of 18° 20' 55", a distance of 365.48 feet, to a set 1/2-inch iron rod with Stantec Cap for corner;

**Thence**, S 44° 21' 12" E, 26.69 feet, to a found 1/2-inch iron rod for the South corner of the herein described tract;

**Thence**, along the arc of a curve to the left, having a chord of N 69° 02' 38", W, 354.48 feet, a radius of 985.37 feet and a central angle of 20° 43' 28", a distance of 356.42 feet, to a point of tangency for corner;

**Thence**, N 79° 20' 28" W, 43.10 feet, to a point for the most Westerly corner of the herein described tract;

**Thence**, N 45° 24' 32" E, 21.05 feet, to the **Point of Beginning**, containing 0.0958 acres (4,171 square feet) of land, more or less.

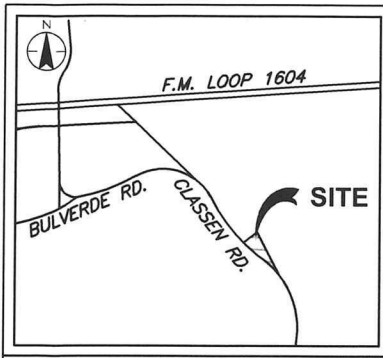
