**ORDINANCE**

**APPROVING A CONTRACT WITH FOR GOOD ENVIRONMENTAL LLC TO PROVIDE WASTE/RECYCLING DISPOSAL SERVICES FOR THE SOLID WASTE MANAGEMENT DEPARTMENT FOR AN ESTIMATED AMOUNT OF \$200,000.00 ANNUALLY, BEGINNING UPON AWARD AND ENDING MARCH 31, 2025, WITH THE OPTION TO RENEW FOR AN ADDITIONAL ONE-YEAR PERIOD. FUNDING IS FROM THE SOLID WASTE OPERATING AND MAINTENANCE FUND.**

**WHEREAS**, an offer was submitted by For Good Environmental LLC through the Texas Local Government Purchasing Cooperative (a.k.a. the “Buyboard”), to provide waste/recycling disposal services for the Solid Waste Management Department for an estimated amount of \$200,000 annually; and

**WHEREAS**, approval of this ordinance will authorize a contract with For Good Environmental LLC beginning upon award and ending March 31, 2025, with the option for the City to renew for an additional one-year period contingent upon BuyBoard’s renewal of the underlying cooperative contract No. 694-23, Waste Recycling Containers (Residential/Commercial) and Waste Disposal Services Equipment, which currently expires on March 31, 2025, and may be subject to a one-year renewal; and

**WHEREAS**, this purchase meets the requirements under the terms of the Texas Local Government Purchasing Cooperative agreement adopted by the City of San Antonio by Ordinance No. 97097 on January 30, 2003; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The offer submitted by For Good Environmental LLC to provide waste/recycling disposal services for the Solid Waste Management Department for an estimated amount of \$200,000 annually, beginning upon award and ending March 31, 2025, with the option for the City to renew for an additional one-year period, is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheet and contract are attached hereto and incorporated herein for all purposes as **Exhibit I.**

**SECTION 2.** Funding for this ordinance in the amount of \$200,000.00 is available in Fund 55001000, Cost Center 5501010001 and General Ledger 5201041 as part of the Fiscal Year 2024 Adopted Budget approved by City Council.

**SECTION 3.** Additional funding is contingent upon City Council approval of the Fiscal Year 2025 and subsequent budgets that fall within the term of the contract.

**SECTION 4.** Payment in the amount of \$400,000.00 is authorized to For Good Environmental LLC and should be encumbered with a purchase order.

**SECTION 5.** The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager, or the City Manager’s designee, correct allocation to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

**SECTION 6.** This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
