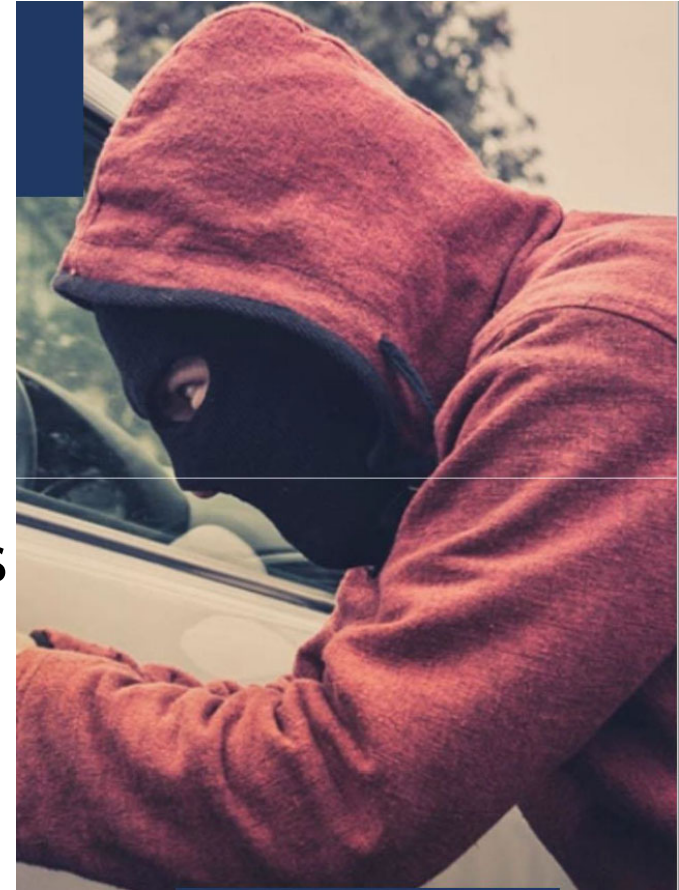

Program Background



- Grant established in 1993 as a multijurisdictional task force
- ReACT is partially funded through the state of Texas Motor Vehicle crime prevention (MVCPA)
- Grant goal is to lower automobile burglary and theft rates by instituting innovative enforcement and theft prevention techniques

Program Background



- Task Force is comprised of:
 - San Antonio Police Department
 - Texas Department of Public Safety
 - Guadalupe County Sheriff's Office
 - National Insurance Crime Bureau

Program Activities



- **Primary Goals of the Taskforce:**
 - Reduce auto burglary, auto theft, and related gateway crimes
 - Investigate and solve active cases and prosecute offenders
- **Education:**
 - Public Awareness Campaigns
 - Community Outreach

Program Activities



- Since 2011, San Antonio ReACT has recovered 11,982 vehicles valued at \$150.7 million
- In 2023 alone, taskforce:
 - Arrested 539 individuals
 - Cleared 311 warrants
 - Executed 50 Search Warrants
 - Recovered 1,526 vehicles valued at \$28.53 million

Program Activities



■ **Proactive Measures:**

- ▶ Conduct salvage yard inspections
- ▶ Perform interdiction activities
- ▶ Locate chop shops
- ▶ Identify automotive organized crime
- ▶ Apprehend criminals committing vehicle theft and burglary of vehicles
- ▶ Conduct operations targeting offenders
- ▶ Perform state required 68-A Inspections
- ▶ Perform VIN etching services
- ▶ Attend community events to educate the public

- Grant Period: September 1, 2024, through August 31, 2025
- Grant Amount: \$1,411,929
- City Match:
 - In-Kind Match - \$3,224,364
 - Cash Match - \$488,617
- NICB Cash Match: \$101,872
- Texas DPS In-Kind Match: \$136,485
