

## **RESOLUTION**

### **ALLOCATING THE CITY'S 1010 VOTES IN FAVOR OF ITS NOMINEE, DR. ADRIANA ROCHA GARCIA, FOR ELECTION TO THE BEXAR APPRAISAL DISTRICT BOARD OF DIRECTORS.**

**WHEREAS**, the Bexar Appraisal District Board of Directors is comprised of nine members, five of which are appointed by various taxing entities, and as a taxing unit, the City is entitled to nominate up to five candidates to sit on the Bexar Appraisal District Board of Directors; and

**WHEREAS**, in accordance with Section 6.0301 of the Texas Property Tax Code (the "Code"), members appointed in this cycle shall draw lots at the first meeting of 2025 to determine which two shall serve a one-year term, beginning January 1, 2025, and expiring on December 31, 2025, and which three shall serve a term of three years, beginning January 1, 2025, and expiring on December 31, 2027; and

**WHEREAS**, on October 3, 2024, the City Council approved Resolution No. 2024-10-03-0038R, nominating Dr. Adriana Rocha Garcia as the City's candidate for reelection to the Bexar Appraisal District Board of Directors; and

**WHEREAS**, in accordance with the Code, the Resolution was submitted to the Chief Appraiser who returned the ballot to the City Council to allocate the necessary votes and submit the votes on the Official Ballot to the Chief Appraiser; and

**WHEREAS**, the total number of votes allocated to the City of San Antonio is 1010, which is determined by a formula based on each taxing district's percentage of property tax imposed in the district for the preceding year; and

**WHEREAS**, the City Council desires to allocate its votes for the Bexar Appraisal District Board of Directors; **NOW THEREFORE:**

### **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City of San Antonio allocates its 1010 votes in favor of Dr. Adriana Rocha Garcia to serve on the Bexar Appraisal District Board of Directors.

**SECTION 2.** The City of San Antonio must submit this Resolution along with the Official Ballot with the number of allocated votes to the Chief Appraiser before December 15, 2023. The Chief Appraiser will count the votes and declare the five candidates with the greatest number of votes elected and submit the results to each taxing entity by December 31, 2023.

**SECTION 3.** This Resolution is effective immediately upon passage by eight affirmative votes; otherwise, it is effective on the tenth day after passage.
