**ORDINANCE**

**AWARDING CITY COUNCIL PROJECT FUND GRANT ALLOCATIONS TO FIELD TRIPS AND MORE TO MAGIK THEATRE IN THE AMOUNT OF \$12,840.92; THE DISTRICT 8 BACK-TO-SCHOOL EVENT IN THE AMOUNT OF \$13,000.00; AND THE DISTRICT 4 BACK-TO-SCHOOL EVENT IN THE AMOUNT OF \$15,000.00.**

**WHEREAS**, the City Council Project Fund was established in 2011 to provide financial support for events and programs that serve a municipal purpose and promote (1) the health, safety and welfare of the community; (2) family, social and economic stability; (3) community fitness/recreation; and (4) community education and training; and

**WHEREAS**, City Council approval is required for City Council Project Fund allocations exceeding \$10,000 to an applicant for the same program, activity, event, good, or service; and

**WHEREAS**, the Field Trips and More to Magik Theatre program provides free tickets to local elementary school children so they may attend a performance at the Magik Theatre, and to provide in-school performances; and

**WHEREAS**, the Districts 4 and 8 Back to School events gave out backpacks full of school supplies in preparation for the upcoming school year; and

**WHEREAS**, these events meet the objectives set out in the CCPF Guidelines and it is the desire of City Council to support and approve these requests to reimburse San Antonio Sports for program costs; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
