ORDINANCE

APPROVING A CONTRACT WITH BUD GRIFFIN & ASSOCIATES - SAN ANTONIO, LLC, TO REPLACE END OF LIFE COMPUTER ROOM AIR CONDITIONING (CRAC) UNITS FOR THE CITY OF SAN ANTONIO'S DATA CENTER FOR A TOTAL COST OF \$997,924.98. FUNDING IS FROM TAX NOTES AND INCLUDED IN THE FY 2024 - FY 2029 CAPITAL IMPROVEMENT PROGRAM.

WHEREAS, offers were submitted to replace end of life computer room air conditioning (CRAC) units located within the City of San Antonio Data Center, which are required to be consistent with the existing engineering design; and

WHEREAS, two proposals were received and evaluated based on the published specifications; and

WHEREAS, City staff recommends accepting the offer submitted by Bud Griffin & Associates - San Antonio, LLC, for a total cost of \$997,924.98; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; and

WHEREAS, funding for this contract, in the amount of \$997,924.98 is available from the FY 2023 – FY 2028 Information Technology Services Department Capital Budget; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer submitted by Bud Griffin & Associates - San Antonio, LLC, to replace end of life computer room air conditioning (CRAC) units located within the City of San Antonio Data Center for a total cost of \$997,924.98 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Payment not to exceed \$997,924.98 is authorized to be encumbered with a purchase order and made payable to Bud Griffin & Associates - San Antonio, LLC. Payment is in support of Project 09-00159 2023 EOC CRAC Redundancy using WBS 09-0015-09-01-02 with GL 5204050. Funding for this project is provided by Tax Notes and is included in the FY 2024 -FY 2029 CIP Budget.

Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved Operating and/or Capital Budgets for current and future fiscal years.

SECTION 3. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
