ORDINANCE

**AUTHORIZING THE EXECUTION OF AN AMENDMENT TO AN
AGREEMENT WITH TRIPLE P AMERICA, INC. TO INCREASE
THE COMPENSATION IN THE AMOUNT OF \$90,758.08 FOR
ADDITIONAL SERVICES FOR A TOTAL CONTRACT AMOUNT UP
TO \$207,493.08 TO SUPPORT POSITIVE PARENTING EDUCATION
AND REDUCE CHILD ABUSE AND EXTEND THE TERM THROUGH
MARCH 31, 2025.**

WHEREAS, the San Antonio Metropolitan Health District's (Metro Health) Violence Prevention Section facilitates Triple P programming across San Antonio and Bexar County as a child abuse prevention initiative; and

WHEREAS, the Triple P – Positive Parenting Program (Triple P) is an evidence-based system of positive parenting and family support based on social learning, cognitive behavioral therapy, and developmental theory; and

WHEREAS, Metro Health trains practitioners in the Triple P curriculum and provides access to the online parenting classes to parent participants in the San Antonio and Bexar County community; and

WHEREAS, Metro Health supports the expansion and population-level rollout of Triple P in San Antonio and Bexar County to create positive outcomes for families locally; and

WHEREAS, the Triple P program at Metro Health collaborates with Triple P America to provide training, peer support, and technical assistance to community partners who implement the Triple P system, as well as providing direct service to parent participants with a range of Triple P interventions; and

WHEREAS, furthermore, this initiative helps the program fulfill goals outlined in SA Forward under Violence Prevention for expanding parent education programming to prevent child abuse; and

WHEREAS, on September 14, 2023, through Ordinance 2023-09-14-0623, City Council approved the initial agreement with Triple P America, Inc., for the term October 1, 2023 through September 30, 2024, in an amount of \$116,735.00; and

WHEREAS, Metro Health seeks City Council authorization to execute an amendment to an agreement with Triple P America, Inc. to continue to support positive parenting education and reduce child abuse by providing additional services and increasing the agreement in the amount of \$90,758.08, for a total contract value up to \$207,493.08; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the San Antonio Metropolitan Health District or designee, is authorized to execute an amendment to an agreement with Triple P America, Inc. to increase the compensation in the amount of \$90,758.08 for additional services for a total contract amount up to \$207,493.08 to support positive parenting education and reduce child abuse and extend the term through March 31, 2025. A copy of the amendment in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. Funding in the amount of \$90,758.08 for this ordinance is available in Fund 11001000, Cost Center 3618010008 and General Ledger 5201040 as part of the Fiscal Year 2025 Adopted Budget approved by City Council.

SECTION 3. Payment in the amount of \$207,493.08 is authorized to Triple P America, Inc. and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
