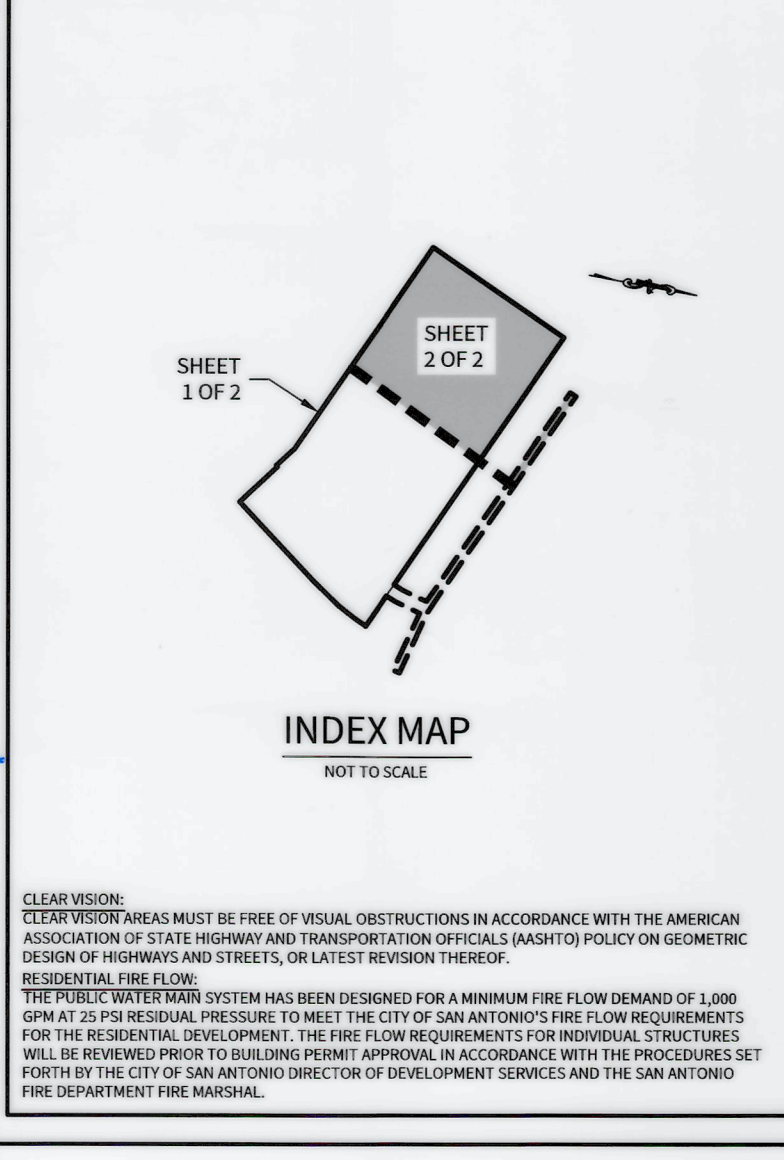
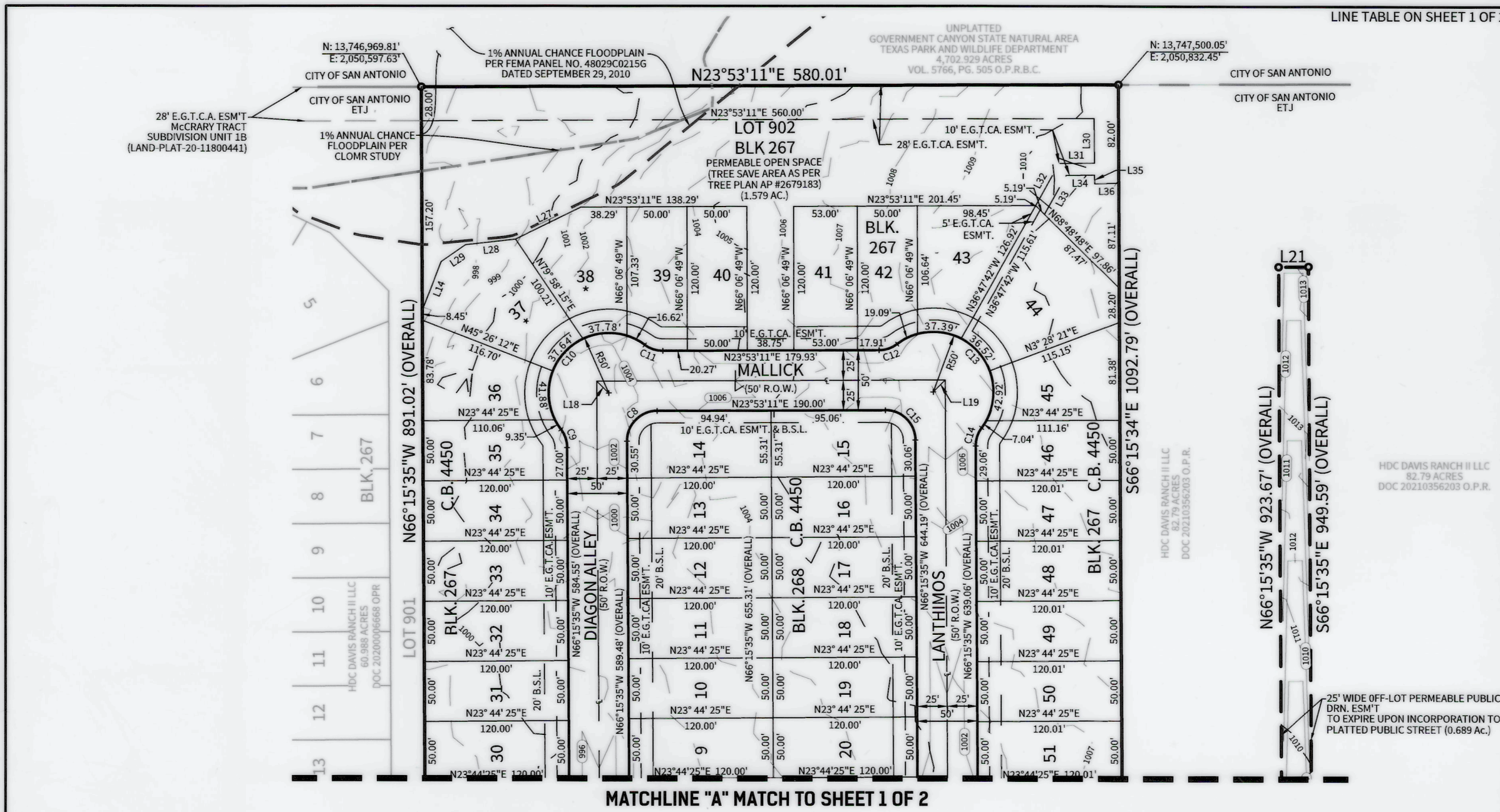
COMMON AREA MAINTENANCE:
