**APPROVING THE RATIFICATION OF A GRANT APPLICATION  
AND ACCEPTANCE OF A GRANT IN THE AMOUNT OF \$1,200.00  
FROM THE TEXAS HISTORICAL COMMISSION FOR TRAVEL  
EXPENSES TO ATTEND NATIONAL ALLIANCE OF  
PRESERVATION COMMISSIONS FORUM.**

**WHEREAS**, Texas Historical Commission offers travel stipends to Certified Local Governments in Texas to attend FORUM 2022 in Cincinnati, Ohio from July 13-17, 2022; and

**WHEREAS**, this grant provides a reimbursement of up to \$1,200.00 for one staff member from the Office of Historic Preservation to attend the FORUM 2022 conference; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or designee, or the Director of the Office of Historic Preservation or designee, authorizes the ratification of a grant application and acceptance of grant funds in the amount of \$1,200.00 from the Texas Historic Commission for travel stipends for individuals to attend FORUM 2022 in Cincinnati, Ohio from July 13<sup>th</sup> to July 17<sup>th</sup>, 2022. A copy of the application is on file with the Office of Historic Preservation.


**SECTION 2.** The City Manager or designee, or the Director of the Office of Historic Preservation or designee, is further authorized to execute any and all necessary documents to effectuate said application and acceptance.

**SECTION 3.** Upon acceptance of this award, new funds and internal order numbers will be created, upon which the award amount not to exceed \$1,200.00 will be appropriated in said funds. A final budget, including Internal Orders and GL Accounts, will be submitted by the Office of Historic Preservation upon award.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


