ORDINANCE

**ORDINANCE APPROVING THE EXECUTION OF A TASK ORDER
UNDER THE EXISTING TRI-PARTY COOPERATIVE
AGREEMENT BETWEEN THE CITY OF SAN ANTONIO, BEXAR
COUNTY, AND THE SAN ANTONIO RIVER AUTHORITY IN AN
AMOUNT NOT TO EXCEED \$3,553,550.00 TO BE PAID TO SAN
ANTONIO RIVER AUTHORITY FOR PROJECT MANAGEMENT,
DESIGN, AND CONSTRUCTION SERVICES RELATED TO THE
2022 CITY BOND WESTSIDE CREEKS LIGHTING PROJECT
LOCATED IN COUNCIL DISTRICTS 1, 3, 5, 6, AND 7.**

WHEREAS, a Tri-Party Cooperative Agreement between the City of San Antonio, Bexar County, and the San Antonio River Authority (“SARA”) allows for SARA to serve as the administrator and project manager for the County’s Rivers, Creeks, Trails and Parks Capital Improvement Program; and

WHEREAS, the Tri-Party Cooperative Agreement allows for the City to assign SARA to manage 2022 City bond-funded linear trail connection projects under the Howard W. Peak Greenway Trails System; and

WHEREAS, the Howard W. Peak Greenway Trails System is a growing network of approximately 92 miles of developed multi-use and accessible trails built through the natural landscapes along the San Antonio waterways; and

WHEREAS, under the proposed Task Order, SARA will serve as the administrator and project manager for the 2022 City bond Westside Creeks Lighting Project, performing vendor procurement and coordinating with the engineers, inspectors, contractors, and permitting agencies on behalf of the City; and

WHEREAS, this project will evaluate feasibility and perform design and construction of trail lighting along the Westside Creeks Greenway Trails, which include Apache, San Pedro, Alazan, Martinez, and Zarzamora Creeks to provide safe access during early morning and late evening hours; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee or the Director of the Parks and Recreation Department or designee is authorized to execute a task order under the existing Tri-Party Cooperative Agreement in an amount not to exceed \$3,553,550.00 to be paid to SARA for project management, design, and construction services related to the 2022 City bond Westside Creeks Lighting Project.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
