The following individuals provided Public Comment to the City Council:

Amy McFadden, a resident of Council District 6, spoke of her concerns related to COVID-19

vaccination availability and use of City of San Antonio Pop-Up clinics and experienced delays and capacity challenges for young children.

Rick Trevino, resident of Council District 3, spoke of his concerns of City Councilmember decorum and economic disadvantages for low-income and the most vulnerable populations in the areas of housing and utility assistance.

Erica Parra, resident of Council District 5, spoke of concerns associated with vacant lot criminal activity on the corner of Guadalupe and Colima Streets associated with homeless encampment population.

Sam Aguirre, resident of Council District 1 near the St. Mary's Entertainment District, spoke of his concerns associated with criminal activity in his neighborhood to include gunshots, speeding, public fights and other misbehavior. He asked the City Council to support upcoming Ordinances addressing noise and commercial zoning.

Columbo Wilson spoke of her concerns of Councilmember Bravo bullying activity and the experiencing of bullying by her son in the church she attends. She spoke of the need for training for individuals to deal with disabled individuals in the community and trauma these individuals experience from bullying. She asked for Police intervention in the bullying incidents.
