ORDINANCE

APPROVING THE EXECUTION OF AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF SAN ANTONIO AND BEXAR COUNTY TO ACCEPT FUNDS IN THE AMOUNT OF \$170,000 FROM BEXAR COUNTY FOR PERIMETER FENCING UPGRADES AT THE OLD SPANISH TRAILS WALKING PARK AND SPORTS FIELDS LOCATED IN COUNCIL DISTRICT 1; AND AUTHORIZING THE APPROPRIATION OF THESE FUNDS FROM BEXAR COUNTY TO THE OLD SPANISH TRAILS PARK PROJECT.

WHEREAS, on May 6, 2017, San Antonio voters approved the City of San Antonio's 2017-2022 Bond Program, of which \$3,075,000 allocated for the Old Spanish Trails Walking Park to transform a pair of stormwater basins of the Laddie III Stormwater Facility Development into 10 acres of sports and recreation fields while continuing to provide the stormwater drainage needed for the area located in Council District 1; and

WHEREAS, on February 21, 2019, City Council approved the construction of new sports fields through Ordinance 2019-02-21-0135 for the Old Spanish Trails Walking Park Project. The project included sports recreation fields, security lighting, electrical service, irrigation system and sports equipment needed to operate a competitive program for youth in San Antonio. The project was completed in December 2019; and

WHEREAS, the fields are located approximately five feet below street level and the existing perimeter fencing is positioned at street level. Heavy use of the park and sports fields requires more perimeter fencing to better secure the athletes, their families, staff, officials, and the facility; and

WHEREAS, the City will utilize the funds from Bexar County authorized through this Interlocal Agreement to upgrade the perimeter fencing at the Old Spanish Trail Walking Park and Sports Fields. The funding will be used to provide for the installation of new fencing and other upgraded enhancements to reinforce existing sections of fencing around the perimeter of the sports fields. Project construction is anticipated to begin in October 2022 and is estimated to be completed by February 2023; and

WHEREAS, it is necessary to execute an Interlocal Agreement between the City of San Antonio and Bexar County to accept funds in the amount of \$170,000 from Bexar County for perimeter fencing upgrades at the Old Spanish Trails Walking Park and Sports Fields located in Council

District 1, and authorize the appropriation of these funds from Bexar County to the Old Spanish Trails Park project; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or his designee, is authorized to execute an Interlocal Agreement between the City of San Antonio and Bexar County to accept funds in the amount of \$170,000 from Bexar County for perimeter fencing upgrades at the Old Spanish Trails Walking Park and Sports Fields located in Council District 1, and authorize the appropriation of these funds from Bexar County to the Old Spanish Trails Park project. A copy of the Agreement in substantially final form is attached as **Exhibit A**.

SECTION 2. The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to execute an Interlocal Agreement between the City of San Antonio and Bexar County. Upon acceptance of the Interlocal Agreement funds in an amount not to exceed \$170,000.00 are authorized to be received from Bexar County.

SECTION 3. Upon acceptance of the funds \$170,000.00 is appropriated and authorized to be transferred to Fund 45099000 General Obligation Capital Projects, Project 23-01692 Old Spanish Trails Park.

SECTION 4. The budget in Project 23-01692 shall be revised by increasing the WBS 23-01692-90-07 with GL 4502280 and WBS 23-01692-05-02-08 with GL 5201245 each by \$170,000.00.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
