Summary



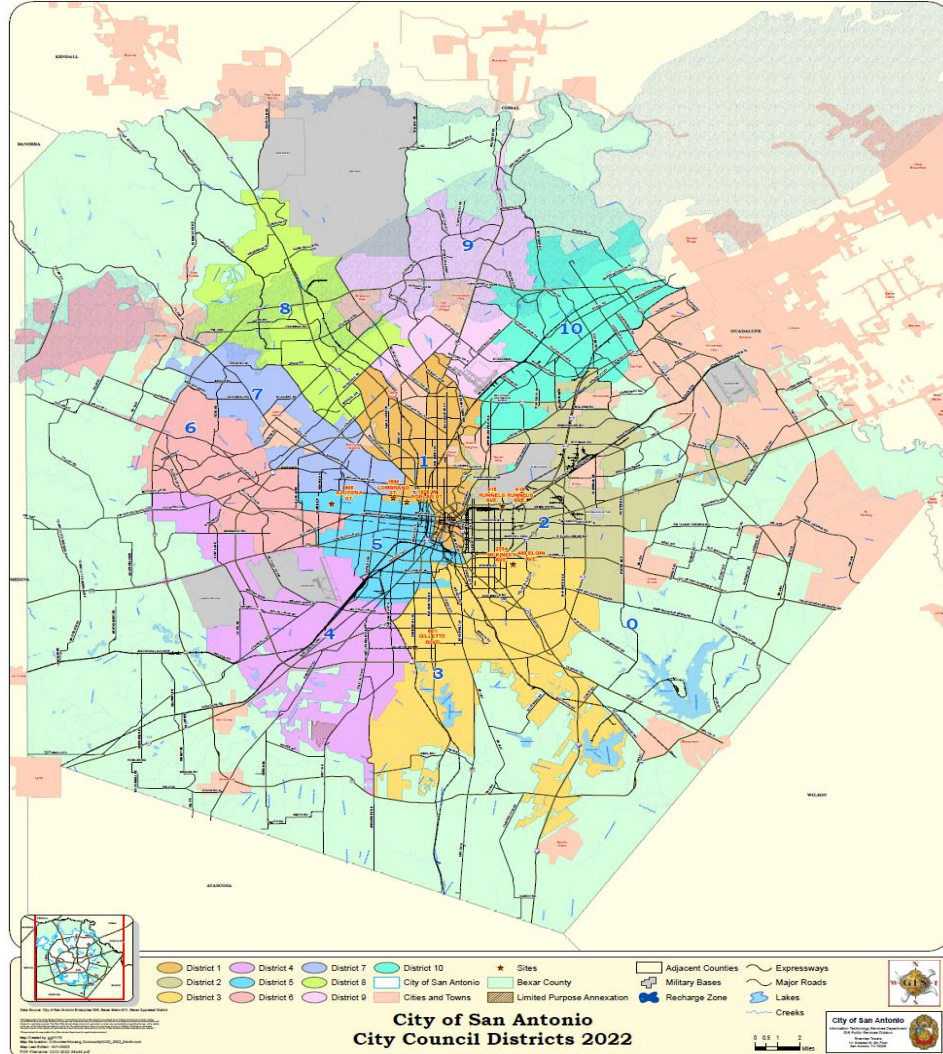
Declares eight (8) City-owned, vacant properties as surplus and approves the conveyance of those properties to the San Antonio Affordable Housing, Inc. (SAAH), non-profit agency of the City's Urban Renewal Agency's, to build affordable housing.

Background



- City recently conducted evaluation of property inventory
- NHSD identified **8 parcels** that would be ideal for affordable housing
 - **7 unimproved single-family** tracts of land in City Council Districts 1, 2, 3 & 5
 - **1 vacant Fire Station** in Council District 3
- City proposes to transfer these properties to San Antonio Affordable Housing, Inc (SAAH) into the REnewSA program for affordable housing
- This has been done in the past with city surplus property San Salvador St. & Denver Blvd. property

REnewSA Examples



Before – Empty Lots at 503, 507, 511 San Joaquin



After – 3 Single-Family Homes



- Declare eight (8) properties as surplus and authorizes the conveyance to SAAH for the REnewSA program.
- SAAH is proposing to build:
 - Seven (7) single-family homes for homeownership for families that earn \leq 120% of the Area Median Income (AMI)
 - One (1) multi-family rental development for families \leq 60% AMI
- This aligns with the City's adopted Strategic Housing Implementation Plan (SHIP)

Recommendation



Declare the eight (8) vacant properties located in Council District 1, 2, 3 and 5 as surplus and convey them to SAAH to be used for affordable housing.
