

RESOLUTION 2022-12-01-0047R

**CONFIRMING THE REAPPOINTMENT OF DR. WILLIS MACKEY TO  
THE CPS ENERGY BOARD OF TRUSTEES FOR A TERM  
COMMENCING FEBRUARY 1, 2023 AND EXPIRING JANUARY 31,  
2028.**

**WHEREAS**, the authority of the CPS Energy Board of Trustees is derived from City ordinances and bond covenants, including the requirement that nominees for vacancies on the CPS Energy Board of Trustees be confirmed by a majority vote of the City Council as evidenced by ordinance or resolution; and

**WHEREAS**, Ordinance No. 87009, as updated by later ordinances including Ordinance No. 2015-06-18-0574, provides that CPS Energy Board of Trustee membership be drawn from all geographic areas of Bexar County, and further designates the Southeast, Southwest, Northeast, and Northwest Quadrants from which membership is to be drawn; and

**WHEREAS**, in Resolution No. 2018-04-05-0023R, the City Council confirmed the appointment of Dr. Willis Mackey to the CPS Energy Board of Trustees representing the Southeast Quadrant for a term commencing on April 6, 2018 and expiring on January 31, 2023; and

**WHEREAS**, on October 31, 2022, the CPS Energy Board of Trustees elected Dr. Willis Mackey for a second term on the CPS Energy Board of Trustees; and

**WHEREAS**, on November 3, 2022, CPS Energy submitted a letter to the City Clerk seeking a City Council resolution confirming the reappointment of Dr. Willis Mackey; and


**WHEREAS**, Dr. Willis Mackey is a resident of Bexar County residing in the Southeast Quadrant; **NOW THEREFORE:**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The reappointment of Dr. Willis Mackey by the CPS Energy Board of Trustees is confirmed for a term commencing February 1, 2023 and expiring January 31, 2028.

**SECTION 2.** This Ordinance becomes effective immediately upon the receipt of eight affirmative votes, or in the event eight affirmative votes are not received, on the tenth day after passage.
