

ORDINANCE

APPROVING THE SAN ANTONIO ECONOMIC DEVELOPMENT FOUNDATION 2023 OPERATIONS PLAN. FUNDING ASSOCIATED WITH THE PLAN WAS APPROVED AS PART OF THE FY2023 ADOPTED BUDGET.

WHEREAS, since 2010, the City of San Antonio (“City”) has contracted with the San Antonio Economic Development Foundation, known as greater:SATX (“gSATX”), for economic development services to enhance the City’s focus on corporate retention and recruitment and to improve resource utilization; and

WHEREAS, in 2016, the City and gSATX realigned the goals and metrics of their Economic Service Agreement to incorporate the Forefront San Antonio Action Plan (“Forefront SA”), which facilitated the creation of 20,000 new jobs and secured \$1.5 billion in capital investment by the end of 2020; and

WHEREAS, in 2021, following conclusion of the Forefront SA Plan, City Council approved an updated Service Agreement (“the Agreement”) with gSATX to support a continued strategic framework that focuses initiatives within three pillars of Jobs, People, and Place; and

WHEREAS, a second and final extension of the Agreement requires the development of an annual Operations Plan approved by the respective governing bodies of both City and gSATX; and

WHEREAS, the 2023 Operations Plan is being submitted by City staff for approval in accordance with the requirements of the Agreement. **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The San Antonio Economic Development Foundation 2023 Operations Plan is hereby approved. A copy of the Operations Plan is attached to this Ordinance as **Attachment I**.

SECTION 2. Funding in the amount of \$635,000.00 for this ordinance is available as part of the Fiscal Year 2023 Adopted Budget approved by City Council per the table below.

SECTION 3: Payment is authorized to San Antonio Economic Development Foundation now known as greater:SATX and should be encumbered with a purchase order.

SECTION 4: The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance

SECTION 5. This Ordinance shall be effective upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage.
