ORDINANCE

APPROVING A CONTRACT WITH CRI ELECTRIC INC., FOR THE APACHE CREEK LINEAR PARK LIGHTING UPGRADES PHASE 2 – RE-BID PROJECT. APPROXIMATELY 34 NEW LED LIGHT FIXTURES WILL BE INSTALLED ALONG WITH NEW LIGHT POLES, NEW LIGHTING PANEL BOARDS, PHOTOCELLS AND CONTROLS. THE CONTRACTORS WILL PROVIDE LABOR, MATERIAL AND EQUIPMENT TO REMOVE AND REPLACE LAMPS, FIXTURES, LIGHTING CONTROLS, AND OTHER EQUIPMENT NECESSARY TO IMPROVE THE EFFICIENCY AND LIGHT QUALITY OF EXISTING INFRASTRUCTURE.

WHEREAS, City Council takes consideration and action is the attached five bid responses received to perform lighting retrofits at Apache Creek Linear Park. The bid responses include a base bid with no alternates.; and

WHEREAS, base bid is for the park route between SW 19th Street and S. Zarzamora Street. The lowest responsive bid was submitted by CRI Electric, Inc. for a total base bid price of \$594,657.00.; and

WHEREAS, current lighting technologies in place can be replaced with newer, more energy efficient LED technology that will reduce electricity consumption and cost, increase light quality thereby creating a positive impact on the environment by reducing greenhouse gas emissions; and;

WHEREAS, approximately 34 new led light fixtures will be installed along with new light poles, new lighting panel boards, photocells and controls. The contractors will provide labor, material and equipment to remove and replace lamps, fixtures, lighting controls, and other equipment necessary to improve the efficiency and light quality of existing infrastructure; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. This project was approved in the FY23 Adopted Budget and will be funded with the Energy Efficiency Fund (EEF). Upon completion, the avoided costs of utilities, as well as CPS Energy rebate monies associated with this project, will be appropriated into the EEF.

SECTION 2. This ordinance authorizes a contract with CRI Electric, Inc. to implement Apache Creek Linear Park Lighting Upgrades Phase 2 – Re-Bid Project for a total cost of \$594,657.00.
