

ORDINANCE

APPROVING THE SETTLEMENT OF LITIGATION STYLED *JESSE QUINONES V. CITY OF SAN ANTONIO*; CAUSE NO. 2018CII8658, IN A TOTAL AMOUNT OF \$150,000.00.

* * * * *

WHEREAS, an auto accident occurred on May 2, 2017, at S. New Braunfels Ave. at Montana, involving a City owned vehicle operated by an employee of the San Antonio Police Department and a vehicle driven by Plaintiff Jesse Quinones; and

WHEREAS, as a result of this accident, Jesse Quinones alleges he suffered injuries and incurred medical expenses, and has filed suit seeking to recover damages; and

WHEREAS, although the City of San Antonio has vigorously contested this matter, it is in the City's best interest to settle this matter to avoid the uncertainties and risks associated with further litigation; and

WHEREAS, the parties have reached an agreement to settle the claims of Jesse Quinones in the amount of \$150,000 payable from the Self-Insurance Liability Fund subject to City Council approval; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The amount of \$150,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund, General Ledger 5402530 General Liability Claims, Cost Center 7509020001 Risk Management-Liability, and is authorized to be made payable in two checks as follows:

- 1) \$34,441.07 payable to the Attorney General of Texas (for OAG Case Numbers 0009879237 and 0011666811) TEXAS CHILD SUPPORT DISBURSEMENT UNIT INSURANCE INTERCEPT, P O Box 245996, San Antonio, TX 78224-5996 / AG Tax ID # 746000057; and
- 2) \$115,558.93 payable to Jesse Quinones and Davis Law Firm.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
